Sub: Closing Order for Appeal Case.

WHEREAS, under Section 19 of the RTI Act, 2005 and in accordance to the Nagaland State Information Commission (Appeal Procedure) Rules-2005, the Commission had heard the second appeal dated 24.05.2017 for the third time on 14.02.2019 at 2:00 P.M. which was submitted by Shri. Devinder Sharma, Krishna Cottage, 27-D, Dayal Bagh, Ambala Cantt. 133001, Haryana, Mobile No. 9876140198, email:sharmadevinder1953@gmail.com against the non-response of the First Appellate Authority to his first appeal dated 30.03.2017 which was submitted against the non-response of the District Transport Officer, Kohima to his RTI application dated 31.10.2016.

AND WHEREAS, after the third hearing held on 14.02.2019 at 2:00 P.M., the Commission had passed decision of even No. dated 21.02.2019

AND WHEREAS, in compliance to the decision of the Commission dated 21.02.2019, the Commission had, vide letter No.RTO-K/DL/3/2017/PT-II/1184 dated 18.03.2019 received the sworn affidavit dated 13.03.2019 signed by Smti. Keneingunuo Clara, former RTO & PIO, Kohima (now Deputy Transport Commissioner) declaring that the RTI application dated 31.10.2016 purported to have been submitted to the Office was not traceable. She further stated that the office of the Regional Transport Officer, Kohima alongwith all the files, records, furniture, etc., Was burned down during the unfortunate riot incident on 2nd February, 2017.

AND WHEREAS, as decided in the last hearing, since the above compliance have been received, the Commission has decided to close the Appeal case.
