Sub: Closing Order of Appeal Case.

WHEREAS, under section 19 of the Right to Information Act, 2005 and in accordance to the Nagaland State Information Commission (Appeal Procedure) Rules 2005, the Commission had, on two occasions on 30.10.2017 at 12:00 Noon and 23.05.2018 at 1:00 P.M. heard the second appeal dated 21.07.2017 submitted by Shri. Sabu Sote, Phekerkrie Basa under Chiephobozou Block, Kohima, Mobile No.9862288287 against the non-satisfaction of information furnished in response to his RTI application dated 09.12.2016 and his first appeal dated 02.05.2017.

AND WHEREAS, after the hearings on 30.10.2017 at 12:00 Noon and 23.05.2018 at 1:00 P.M, the Commission had passed decisions of even No. dated 15.11.2017 and 05.06.2018 respectively.

AND WHEREAS, in compliance to the second decision of the Commission dated 05.06.2018, Shri. Razouseyi Vese, Additional Director (HSS) & PIO, Directorate of School Education, Nagaland, Kohima had, vide letter No.ED/RTI-A/2014-15 dated 19.06.2018 submitted the following:-

1. Regarding **Point No.1**, the details of the nature/ reason of appointment and educational qualification of the three (3) employees viz (i).Smti. Aleno D/o Lt.Khrietsielie, Chowkidar at GMS Phekerükriema, (ii).Smti.Kekhrieno D/o Lt.Khrietsielie, Typist Grade-III at DEO, Kohima Estt. and (iii).Smti.Keneisanuo D/o Lt.Khrietsielie, Peon at DSE. However, for the remaining five (5) names namely a).Shri.Avilie S/o Lt.Khrietsielie b).Smti.Keneisanau D/o Lt.Khrietsielie, c).Shri.Shilo H/o Keneisanau (Son-in-law of Lt.Khrietsielie, d).Smti.Meziengu-u D/o Thepfuvilie (niece of Lt.Khrietsielie) and e).Smti.Kenei W/o Lt.Kezhawheto (Daughter-in-law of Lt.Khrietsielie) a sworn affidavit dated 11.06.2018 was submitted declaring that they are not employed in the School Education Department.
2. Regarding **Point No.2**, an extract copy of the relevant section of the Nagaland Services (Discipline and Appeal) Rules, 1967 that there was no specific duration for suspension.
3. Regarding **Point No.3**, letter of satisfaction of information furnished from the applicant (now appelland) dated 09.07.2018.
4. Regarding **Point No.4**, penalty amount of `25,000/- deposited into Government account through Treasury Challan No.74 dated 19.06.2018.

AND WHEREAS, since all the above compliances have been received from the Public Authority, the Commission has decided to close the appeal case.

NOW THEREFORE, it is notified to all the parties that this appeal case is hereby declared as **closed**.
