**Subject: Closing Order of Appeal Case.**

WHEREAS, under section 19 of the RTI Act, 2005 and in accordance to the Nagaland State Information Commission (Appeal Procedure) Rules, 2005, the Commission had, on 12.04.2018 at 12:00 P.M. heard the second appeal dated 12.08.2015 preferred by Shri. Vinod Sharma, S/o Shri. K.K. Sharma, F-85, Moti Bagh 1, New Delhi-110021, Mobile No. 096544517/09891497733 against the non-response of the First Appellate Authority, The Global Open University Nagaland to his first appeal dated 02.07.2015 which was submitted against the non-response of the PIO to his RTI application dated 16.04.2015.

AND WHEREAS, after the hearing on 12.04.2018 at 12:00 Noon, the Commission had passed decision of even No. dated 20.04.2018.

AND WHEREAS, in Compliance to the **Point No. 1** of the decision of the Commission dated 20.04.2018, Dr. Imotemsu Ao, Director-cum-Registrar & FAA, The Global Open University Nagaland had, vide letter No. GOUN/2-14/16B VOL-II/301 dated 06.07.2018 submitted a copy of email dated 30.06.2018 written by the applicant (now appellant) and addressed to the AAO & PIO stating satisfaction with the information furnished to him on 30.11.2015.

AND WHEREAS, in compliance to **Point No. 2** of the decision of the Commission dated 20.04.2018 Dr. Imotemsu Ao, Director-cum-Registrar & FAA had, vide letter No. GOUN/2-14/16B VOL-II/301 dated 06.07.2018 submitted that he had, vide letter No. GOUN/2-14/16/B VOL I/42 dated 23.02.2018 given his reply to the explanation call issued by the Commission, however since the Commission did not accept his reply as the Vice Chancellor had given the response, he had again given the reply himself vide letter No. GOUN/2-14/16/B VOL I/47 dated 08.03.2018 and vide letter No. GOUN/2-14/16/B VOL I/104 dated 02.04.2018.

AND WHEREAS, in compliance to the **Point No. 3** of the decision of the Commission dated 20.04.2018, Dr. Imotemsu Ao, Director-cum-Registrar & FAA, The Global Open University Nagaland had, vide letter No. GOUN/2-14/16B VOL-II/301 dated 06.07.2018 submitted a copy of the Treasury Challan No. 18 dated 18.07.2018 for an amount of Rs. 25,000/- towards payment of penalty imposed on Shri. Keluozie Kesiezie, Assistant Administrative Officer & PIO.

AND WHEREAS, since all the above compliances to Point Nos. 1, 2 & 3 of the decision of the Commission dated 20.04.2018 have been received, the Commission has decided to close the appeal case.
