**Sub: Closing Order for Appeal Case.**

WHEREAS, under Section 19 of the RTI Act, 2005 and in accordance to the Nagaland State Information Commission (Appeal Procedure) Rules, 2005, the Commission had, on 25.07.2018 at 2:00 P.M. heard the second appeal dated 25.09.2017 submitted by Shri. L. Tonen Chang, Assistant Finance Secretary, Eastern Naga Students' Federation, Perizie Colony, High School, Kohima, Mobile No. 7308967875/ 7630805412 against the non-response of the First Appellate Authority (FAA), Nagaland Public Service Commission (NPSC), Nagaland, Kohima to his first appeal dated 08.08.2017 which was submitted against the non-satisfaction of information furnished to him in response to his RTI application dated 06.06.2017.

AND WHEREAS, after the hearing held on 25.07.2018 at 2:00 P.M., the Commission had passed decision of even No. dated 07.08.2018.

AND WHEREAS, in compliance to the above decision of the Commission dated 07.08.2018, Shri. Kelhouseto Nakhro, Deputy Secretary & PIO, NPSC, Kohima had, vide letter No.NPSC/RTI/2005(VOL-II) dated 27.09.2018 submitted the following information:-

1. Regarding **Point No.1**, since the applicant (now appellant) had refused to accept the information furnished vide letter No.NPSC/RTI/2005(VOL-II) dated 06.09.2018 on the ground that Roster Table was not indicated, the information was re-furnished with the Roster Table and Roster Point No. of various point till the last declared examination of the following examination, viz, (a). NCS, NPS, NSS and Allied Services Examination 2016 and (b). Combined Technical Services Examination-2016 and Common Educational Services Examination-2016, as per the Rooster Table notified vide No.RCBT-5/87 (Pt-II) dated 14.04.2011
2. Regarding **Point No.2**, the number of applications received for the Special Recruitment of EAC, the fee was `200/- and not `300/- as recorded. The total money deposited with the Treasury was `5,30,800/-, hence the total No. of applications would be 2654.
3. Regarding **Point No.4**, a copy of the Treasury Challan No.29 dated 13.09.2018 for the penalty amount of `5250/- (Rupees Five Thousand Two Hundred and Fifty only) deposited into Government account.

AND WHEREAS, in compliance to **Point No.3** of the decision of the Commission dated 07.08.2018, the Commission had received satisfaction vide letter dated 25.01.2019 from the representatives of the applicant (now appellant), Shri. Kaibo Konyak, Education Secretary, ENSF and Shri. Manpang Wangyen, Vice President, ENSF.

AND WHEREAS, since all the above compliances to its decision have been received and that the applicants (now appellants) had also expressed satisfaction, the Commission has decided to close the appeal case.

NOW THEREFORE, it is notified to all the parties that this appeal case is hereby declared as **closed**.
