Sub: Closing Order for Appeal Case.

WHEREAS, under Section 19 of the RTI Act, 2005, and in accordance to the Nagaland State Information Commission (Appeal Procedure) Rules, 2005, the Commission had on 18.09.2018 dated 12:00 Noon heard the second appeal dated 27.09.2017 submitted by Shri. Sunil Mallan & Shri. Kamal Kant, Booth No. 14-B, Sector 47-C, Chandigarh-160047, email-advsunilmallan@gmail.com, Mobile No. 9814096353 against the non-response of the First Appellate Authority to their first appeal dated 12.06.2017 which was submitted against non-satisfaction of the information furnished by the PIO, The Global Open University Nagaland to their RTI application dated 04.05.2017.

AND WHEREAS, after the hearing held on 18.09.2018 at 12:00 Noon, the Commission had passed decision of even No. dated 24.09.2018.

AND WHEREAS, in compliance to the **Point No.1** of the decision of the Commission dated 24.09.2018, Shri. Keluozie Kesiezie, AAO-I & PIO, The Global Open University Nagaland had, vide letter No.GOUN/2-14/16/A Vol-II/354 dated 24.09.2018 wrote to the applicant (now appellant) and with a copy to the Commission to confirm satisfaction or non-satisfaction of the information in written on or before 25.10.2018, failing which the information so furnished to him would be presumed as satisfied by him.

AND WHEREAS, in compliance to the **Point No.2** of the decision of the Commission dated 24.09.2018, Shri. Sushil Singh, Controller of Examination & FAA, The Global Open University Nagaland had, vide letter No.GOUN/2-14/16A Vol-II/422 dated 29.10.2018 submitted a copy of Treasury Challan No.28 dated 25.10.2018 for an amount of `2000/- (Rupees Two Thousand only) for contributing to the delay of 8 days which was imposed on Shri. Keluozie Kesiezie, AAO-I & PIO, The Global Open University Nagaland. Further, he submitted that he had vide letter No.GOUN/2-14/16/A Vol-II/354 dated 24.09.2018 requested the applicant (now appellant) to submit satisfaction or non-satisfaction report before 25.10.2018, however, there was no response from the applicant (now appellant) till date.

AND WHEREAS, all the above compliances have been received from the Public Authority, however since there was no response from the applicant (now appellant), though sufficient time had lapsed, suggesting that the applicant (now appellant) have no interest to pursue his case further, the Commission has decided to close the appeal case.
