**Sub: Closing Order for Appeal Case.**

WHEREAS, under Section 19 of the RTI Act, 2005 and in accordance to the Nagaland State Information Commission (Appeal Procedure) Rules, 2005, the Commission had, on 17.04.2018 at 1:00 P.M. and 25.07.2018 at 1:00 P.M. heard the second appeal dated 26.10.2017 preferred by Shri. Hiareuchi N dang, Perenkipeujang Village, Peren Town, Mobile No.9436613106 against the non-response of the Director & First Appellate Authority, Rural Development, Nagaland, Kohima to his first appeal dated NIL which was submitted against the non-response of the PIO, District Rural Development Agency (DRDA), Peren to his RTI application dated 09.08.2017.

AND WHEREAS, after the second hearing held on 25.07.2018 at 1:00 PM, the Commission had passed second decision of even No. dated 03.08.2018.

AND WHEREAS, in compliance to the above decision dated 03.08.2018, Shri.Henito Achumi, Accounts Officer, DRDA, Peren had, vide letter No.DRDA/PRN/RTI/2017-18 dated 27.09.2018 submitted that the penalty amount of `17,500/- (Rupees Seventeen Thousand Five Hundred only) which was imposed on Smti. Imtimenla, former Project Director & PIO, DRDA, Peren (now Deputy Secretary), Nagaland had been deposited into the Government account vide Treasury Challan No.10. dated 31.08.2018 and had enclosed a copy of the Treasury Challan.

AND WHEREAS, as decided in the last hearing, since the above compliance has been received, the Commission has decided to close the Appeal case.
