Sub: Closing Order of Appeal Case.

WHEREAS, under section 19 of the RTI Act, 2005 and in accordance to the Nagaland State Information Commission (Appeal Procedure) Rules 2005, the Commission had, on 15.02.2018 at 2:00 P.M. heard the second appeal dated 27.07.2016 preferred by Shri. Mahindra Nath Jha, Qtr No. D-29/2, BRBNMPL SALBONI, West Midnapur, West Bengal, 721132, Mobile No. 9476247188, email:capt.mnjha@rediffmail.com against the non-response of the Director-cum-Registrar & First Appellate Authority, to his first appeal dated 20.04.2016 which was submitted against the non-response of the PIO, The Global Open University Nagaland, Dimapur to his RTI application dated 08.02.2016.

AND WHEREAS, after the hearing on 15.02.2018 at 2:00 P.M, the Commission had passed decision of even No. dated 19.02.2018.

AND WHEREAS, on not getting any compliance to the above decision, the Commission had, vide letter of even No. dated 18.06.2018 directed the Director-cum-Registrar & FAA and the PIO, The Global Open University Nagaland, Dimapur to comply with the Commission's decision within 15 (Fifteen) days from the issue of the directive.

AND WHEREAS, in response to the directive of the Commission dated 18.06.2018, Dr. Imotemsu Ao, Director-cum-Registrar & FAA had, vide letter No. GOUN/2-14/16/B VOL-II/272 dated 02.07.2018 stated that the following compliances had already been submitted to the Commission:

1. Regarding **Point No. 1**, Dr. Imotemsu Ao, Director-cum-Registrar & FAA had, vide letter No. vide letter No. GOUN/2-14/16/B VOL-1/103 dated 02.04.2018 informed that the First Appeal was not held since the applicant had vide his letter dated 14.09.2017 expressed satisfaction with the information furnished to him and had requested the Commission to close the case.

Further, the Director-cum-Registrar & FAA had, vide letter No. GOUN/2-14/16/B VOL-I/104 dated 02.04.2018 submitted his reply to the explanation stating that his failure to attend the hearing on 15.02.2018 was on health ground and not undermining the Commission.

2. Regarding **Point No. 2**, Shri. Keluozie Kesiezie, Assistant Administrative Officer & PIO, The Global Open University Nagaland had, vide letter No. GOUN/2-14/16/B VOL-1/110 dated 11.04.2108 informed that the penalty amount of ` 22,000/- had been deposited into Government account through Treasury Challan No. 9 dated 09.04.2018.

AND WHEREAS, since the above compliances have been received from the Public Authority and that the applicant (now appellant) had vide letter dated 14.09.2017 expressed satisfaction with the information, the Commission had decided to close the appeal case.

NOW THEREFORE, it is notified to all the parties that this appeal case is hereby declared as **closed**.
