Sub: Closing Order for Appeal Case.

WHEREAS, under section 19 of the RTI Act, 2005 and in accordance to the Nagaland State Information Commission (Appeal Procedure) Rules, 2005, the Commission had, on 19.04.2018 at 12:00 P.M. heard the second appeal dated 30.01.2018 submitted by Shri.Vilhousielie Kenguruse, President, Nagaland Pradesh Youth Congress (NPYC), Mobile No. 9774037529 against the DGP & First Appellate Authority, PHQ, Nagaland, Kohima for non-furnishing of the remaining information sought by him despite the hearing of the first appeal dated 31.10.2017 which was preferred against the non-satisfaction of the information furnished to him by the PIO, O/o the DGP, PHQ, Nagaland, Kohima in response to his RTI application dated 01.09.2017.

AND WHEREAS, after the hearing on 19.04.2018 at 12:00 P.M, the Commission had passed decision of even No. dated 30.04.2018.

AND WHEREAS, in compliance to the above decision dated 30.04.2018, the Inspector General of Police & PIO, O/o the Director General of Police, Nagaland, Kohima had, vide letter No.PHQ(CON-II)185/RTI/Appeal/2016/427 dated 25.05.2018 (but signed on 24.05.2018) furnished the documents of the appointees and whatever information found or available to the applicant (now appellant).

AND WHEREAS, as decided in the last hearing, on receipt of the information, the applicant (now appellant) was to submit his satisfaction or non-satisfaction within 10 days, however since sufficient time had lapsed there was no response or further appeal from the applicant (now appellant) even after the PIO had furnished the information on 25.05.2018, suggesting that the applicant was satisfied with the information so furnished by the PIO, the Commission has decided to close the appeal case.

NOW THEREFORE, it is notified to all the parties that this appeal case is hereby declared as **closed.**
