Subject: Closing Order of Appeal case.

WHEREAS under Section 19 of the Right to Information Act, 2005, and in accordance to the Nagaland State Information Commission (Appeal Procedure) Rules, 2005, the Commission had received a second appeal dated **27.04.2017** from Shri. Vikheto Zhimomi, P.R. Hill, Kohima, Nagaland, Mobile No. 9089896123 against the non-satisfaction of information furnished by the IGP (HQ) & PIO, O/o the Director General of Police, Nagaland in response to his RTI application dated **21.09.2016** and subsequent first appeal dated **24.11.2016**.

AND WHEREAS, on receipt of the above second appeal, the Commission had heard the appeal case on 15.09.2017 at 11:00 A.M and passed its decision vide even No. dated 22.09.2017.

AND WHEREAS, in compliance to the decision of the Commission of even No. dated 22.09.2017, the IGP (Hqr) & PIO, O/o the Director General of Police, PHQ, Nagaland, Kohima had, vide letter No. PHQ (CON-II) 185/RTI/2015-16 dated 03.10.2017 furnished the information to the applicant (now appellant).

AND WHEREAS, on receipt of the information, the applicant (now appellant) had submitted to the Commission regarding his satisfaction of information furnished to him vide letter dated NIL.

AND WHEREAS, though there was a delay of three (3) days in furnishing the information to the applicant (now appellant), the Commission took a lenient view and hence decided to condone the period of delay.

AND WHEREAS, since the information had already been furnished to the applicant (now appellant) in compliance to the decision of the Commission of even No. dated 22.09.2017 and that the applicant (now appellant) had submitted satisfaction of the information furnished to him, the Commission had decided to declare this appeal case as closed.
