**Subject: Closing Order of Appeal Case.**

WHEREAS, the Commission had, on 08.03.2018 at 2:00 P.M heard the Second Appeal dated 28.06.2017 submitted by Shri. Renet Ntang, Perenkipeuzang village, Peren, Nagaland, Mobile No. 9436015902 via email against the non-response of the Principal Chief Conservator of Forests, Environment, Forest & Climate Change, Nagaland, Kohima to his first appeal which was submitted against the non-response of the Divisional Forest Officer & PIO, O/o of the Divisional Forest Office, Peren Division, Jalukie, Nagaland to his RTI application dated 07.04.2017.

AND WHEREAS, after the hearing on 08.03.2018 at 2:00 P.M, the Commission had passed decision of even No. dated 13.03.2018 wherein Dr. Sentitula, IFS, Divisional Forest Officer & PIO, Peren Division, Jalukie was directed to confirm satisfaction of the information from the applicant (now appellant) **within two (2) weeks** from the date of receipt of this decision, with a copy to this Commission.

AND WHEREAS, after the above hearing, Shri. I. Panger Jamir, IFS, Principal Chief Conservator of Forests, Head of Forest Force & FAA, Nagaland, Kohima had, vide letter No. FE-1/15/2010(RTI)/9041-9042 dated 12.03.2018 wrote to the applicant (now appellant) for confirmation of the satisfaction or non satisfaction of the information furnished to him within fifteen (15) days, and in case of non-response, the information shall considered deemed to be satisfied.

AND WHEREAS, in compliance to the above decision of the Commission of even No. dated 13.03.2018, Dr. Sentitula, IFS, Divisional Forest Officer & PIO, Peren Division, Jalukie had also, vide letter No. PRN-6/128/2006-07/2022-25 dated 19.03.2018 wrote to the applicant (now appellant) for confirmation of the satisfaction or non satisfaction of the information furnished within 2 (Two) weeks failing which the information so furnished on 02.05.2017 shall be considered deemed as satisfied as per the above mentioned letter No. FE-1/15/2010(RTI)/9041-9042 dated 12.03.2018 of the PCCF & FAA.

AND WHEREAS, Dr. Sentitula, IFS, DFO & PIO, Peren Division, Jalukie had, vide letter No. PRN-6/128/2006-07/2080-82 dated 21.03.2018 submitted to the Commission, that the above letter No. PRN-6/128/2006-07/2022-25 dated 19.03.2018 regarding the seeking of confirmation of satisfaction or non satisfaction of the information was personally delivered to the applicant (now appellant), and a photocopy of the **peon book** wherein the applicant (now appellant) had signed the receipt of the above letter was enclosed.

AND WHEREAS, on completion of the **two (2) weeks** time given to the applicant (now appellant) for the confirmation of his satisfaction or non satisfaction of the information, Dr. Sentitula, IFS, DFO & PIO, Peren Division, Jalukie had, vide letter No. PRN-6/144/2006-07/08-09 dated 04.04.2018 informed the Commission that the applicant (now appellant) had not given any

reply regarding his acceptance/satisfaction within the stipulated time, suggesting that the applicant (now appellant) had accepted the information as per the letter of the PCCF & FAA vide No. FE-1/15/2010(RTI)/9041-9042 dated 12.03.2018.

AND WHEREAS, Shri. I. Panger Jamir, IFS, Principal Chief Conservator of Forests, Head of Forest Force & FAA, Nagaland, Kohima had also, vide letter No. FE-1/15/2010(RTI)/203 dated 12.04.2018 informed the Commission that the applicant (now appellant) was given an opportunity to accept or reject the reply given by the PIO, Peren Division within fifteen (15) days, however there was no response from the applicant (now appellant) even after the lapse of the stipulated time.

AND WHEREAS, since the above compliance have been received from the Public Authority and though sufficient time had lapsed, there was no response from the applicant (now appellant), suggesting that the applicant have no interest to pursue his case further, the Commission has decided to close the appeal case.

NOW THEREFORE, it is notified to all the parties that this appeal case is hereby declared as **closed**.
