WHEREAS, the Commission had, after hearing the second appeal dated 29.05.2017 for the second time on 24.04.2018 at 2:00 P.M, passed its decision dated 30.04.2018 wherein the District Transport Officer & PIO, Tuensang was directed to furnish the Notification dated 01.08.2009 to the applicant (now appellant) within 15 days from the date of receipt of its decision with a copy to the Commission.

AND WHEREAS, in compliance to the decision of the Commission dated 30.04.2018, the Transport Commissioner & FAA had, vide letter No.TC/Estt-RTI/Appeal/302/2014(163)/ 1482-83 dated 24.05.2018 stated that in his earlier letter dated 23.10.2017, it was erroneously mentioned at point No.2, that the said Notification dated 01.08.2009 was enclosed while furnishing the information to the applicant (now appellant). Further, the Transport Commissioner & FAA stated that the said Notification could not be traced out since numerous office files, record and machines were destroyed and the file having the said Notification too was burned during the protest when office was burnt down on 02.02.2017.
