Subject: Notice for Hearing on 23rd May (Wednesday), 2018 at 1:00 P.M.

WHEREAS, the Commission had, on 30.10.2017 at 12:00 P.M heard the second appeal dated 21.07.2017 submitted by Shri. Shri. Sabu Sote, Phekerkrie Basa under Chiephobozou Block, Kohima, Mobile No. 9862288287 against the non-satisfaction of information furnished in response to his RTI application dated 09.12.2016 and first appeal dated 02.05.2017.

AND WHEREAS, the Commission had, after the hearing passed its decision of even No. dated 15.11.2017. However, since there was no compliance, the Commission had, vide letter of even No. dated 16.02.2018 directed the PIO to submit the compliance to the Commission within 2 (two) weeks.

AND WHEREAS, in compliance to **Point No. 1** of the Commission's decision of even No. dated 15.11.2017 and subsequent directive of even No. dated 16.02.2018, Shri. Razouseyi Vese, Addl. Director (HSS) & PIO, Directorate of School Education, Nagaland, Kohima had, vide letter No. ED/RTI-A/2014-15 dated 08.12.2017 furnished the information to the applicant (now appellant) with a copy to this Commission.

AND WHEREAS, since the compliance to **Point No. 2** of the Commission's decision of even No. dated 15.11.2017 has not been submitted to the Commission and in order to ascertain the cause of delay and fix responsibility on the officer/staff for contributing to the delay in furnishing the information, the Commission had, vide notice of even No. dated 12.03.2018 notified for a hearing on 10.04.2018 at 1:30 PM.

AND WHEREAS, since the Director & First Appellate Authority, the Addl. Director (HSS) & PIO, Directorate of School Education, Nagaland, Kohima and the applicant (now appellant) did not appear for the hearing scheduled on 10.04.2018 at 1:30 PM. as they did not receive the Hearing Notice, the hearing could not be conducted.

AND WHEREAS, the Commission had constituted an Inquiry Committee to enquire into the non-receipt of the above Notice for the hearing, and it was found that the copies of the hearing notice addressed to the Director & First Appellate Authority and the Addl. Director (HSS) & PIO, Directorate of School Education, Nagaland, Kohima were inadvertently sent by speed post to the applicant (now appellant).

AND WHEREAS, the Commission has decided to hear the appeal again, giving opportunity of being heard to all the parties on **23rd May (Wednesday), 2018 at 1:00 P.M in the Hearing Room of Nagaland Information Commission, Below Raj Bhavan, Officers' Hill Colony, Nagaland, Kohima.**
