WHEREAS, under Section 19 of the RTI Act, 2005, and Nagaland State Information Commission (Appeal Procedure) Rules, 2005, the Nagaland Information Commission had on 04.07.2018 at 1:00 P.M. heard the second appeal dated 19.07.2017 submitted by Shri. Prem Rattan Daga, M/s R.D. Trade Agency, C/o M/s Monika (Bombay Dyeing) Church Road, Dimapur 797112 against the non-response of the FAA, PHED to his first appeal dated 06.12.2016 which was submitted against the non-response of the PIO to his RTI application dated 08.09.2016.

AND WHEREAS, after the hearing, the Commission had passed decision vide of even No. dated 13.07.2018 wherein the Additional Chief Engineer & PIO, Office of the Chief Engineer, PHED, Nagaland, Kohima was directed to confirm satisfaction or non-satisfaction of the information from the applicant (now appellant) within 1 (One) month from the date of receipt of this decision, specifying that failure to submit confirmation within the specified time shall deemed to be satisfied.

AND WHEREAS, the Commission had, vide letter dated 16.07.2018 received from the applicant (now appellant) stating that he could not attend the last hearing held on 04.07.2018 at 1:00 P.M. due to medical treatment. He informed that Shri. S. AND WHEREAS, in compliance to the decision of the Commission dated 13.07.2018, Shri. Repangyangba Longkumer, Additional Chief Engineer & PIO, O/o the Chief Engineer, PHED, Nagaland, Kohima had, vide letter No.CE/PHE/M/RTI/2006-07 dated 18.08.2018 submitted that the applicant (now appellant) had vide letter dated 28.07.2018 expressed non-satisfaction with the information so furnished on 20.12.2017.
