Subject: Closing Order of Appeal Case.

WHEREAS, under Section 19 of the Right to Information Act, 2005, the Nagaland Information Commission had received a second appeal vide letter No. 2011126837 dated 21.02.2017 from an applicant, Shri. Deepka Tayde, Block 'A' 301-302, Corporate House, 3rd Floor, TNT Marg, Opp. Jhabua Tower, Indore-452001 against the non-response of the First Appellate Authority, DTO, Phek, Nagaland to his first appeal dated 03.06.2016 which was submitted against the non-response of the PIO & DTO, Phek, Nagaland to his RTI application dated 20.04.2016.

AND WHEREAS, the applicant, Shri. Deepak Tayde had submitted an RTI application vide letter No. 2011126837 dated 20.04.2016 addressed to the PIO, Regional Transport Authority, District Transport Officer, Phek, Nagaland by Registered Post bearing No. E RI131576232IN along with the prescribed application fee of Rs. 10/- paid through IPO bearing No. 26F 070163 seeking the following information regarding Driving License Number 69408/MKG/Proff/2008:-

- i. Driver Name
- ii. Address
- iii. Authorization category
- iv. Authorization validity
- v. Driving License fee deposit receipt No.
- vi. Driving License fee deposit date
- vii. Kindly confirm the validity of driving license on dated (MM/DD/YY) as on 03.11.2011.

AND WHEREAS, on not getting any response from the PIO & District Transport Officer, Phek, Nagaland to his RTI application dated 20.04.2016, the applicant had submitted a first appeal vide letter No. 2011126837 dated 03.06.2016 addressed to the First Appellate Authority, District Transport Officer, Phek, Nagaland - 797108 by registered post.

AND WHEREAS, on not getting any response from the First Appellate Authority to his first appeal dated 03.06.2016, the applicant (now appellant) had preferred a second appeal vide letter No. 2011126837 dated 21.02.2017 before this Commission.

AND WHEREAS, on receipt of the second appeal dated 21.02.2017, the Commission had observed that the applicant (now appellant) had wrongly submitted his first appeal to the First Appellate Authority, DTO, Phek, Nagaland instead of submitting it to the Transport Commissioner & FAA, Motor Vehicles Department, Nagaland, Kohima.

AND WHEREAS, the Commission had, vide letter of even No. dated 07.09.2017 advised the applicant (now appellant) to submit his first appeal before the appropriate/rightful

First Appellate Authority i.e., the Transport Commissioner & FAA, Motor Vehicles Department, Solidary Park, New Secretariat Area, Nagaland, Kohima and further in case of non-response or unsatisfactory decision of the First Appellate Authority within 30-45 days, a second appeal may be preferred to this Commission under Section 19(3) of the RTI Act, 2005.

AND WHEREAS, though sufficient time had lapsed, since there is no response from the applicant (now appellant) till date indicating that the appellant has no interest to obtain information or pursue further, the Commission had decided to close the appeal case.

NOW THEREFORE, it is notified to all the parties that this appeal case is hereby declared as **closed:**-
