Subject: Closing Order of Appeal Case.

WHEREAS, the Commission had, on 18.11.2016 at 1:00 P.M heard the second appeal dated 17.09.2016 submitted by Shri. Sietuo Miachieo and Shri. Medo Nakhro, Viphoma village, Head Post Office, Post Box No.375, Kohima, Mobile No.8256923072, against the non-response of the Additional Deputy Commissioner (ADC) & PIO, Chiephobozou, Kohima to his RTI application dated 30.06.2016 and subsequent first appeal dated 16.08.2016 submitted to the Deputy Commissioner & FAA, Kohima.

AND WHEREAS, after the hearings on 16.11.2017 at 1:00 P.M and 18.11.2016 at 1:00 P.M, the Commission had passed decision of even No. dated 23.11.2016 and 27.11.2017 respectively.

AND WHEREAS, since there were no compliances received within the 2 (Two) weeks time given by the Commission, in its last decision of even No. dated 27.11.2017, the Commission had, vide letter of even No. dated09.02.2018 directed the ADC & PIO, Chiephobozou to comply with point No.1 of its decision dated 27.11.2017; and also vide letter of even No. dated 09.02.2018 directed Smti. Linda Solo, former ADC & PIO to comply to point No.2 of its decision dated 23.11.2016 and 27.11.2017 within 1 month.

AND WHEREAS, in response to the directive dated 09.02.2018 the former ADC & PIO, Smti. Linda Solo, had, vide letter dated 11.03.2018 requested the Commission to give 1 (One) more month's time to submit her explanation letter.

AND WHEREAS, in compliance to the decision of the Commission of even dated 27.11.2017, the Block Development Officer, R.D Block, Chiephobozou vide letter No.RDB/CHB/RTI-1/2016/6 dated 30.11.2017 and the former ADC & PIO Smti. Linda Solo vide letter No. NIL dated 11.04.2018 had submitted the following:-
