Subject: Closing Order of Appeal Case.

WHEREAS under section 19 of the Right to Information Act, 2005 and in accordance to the Nagaland State Information Commission (Appeal Procedure) Rules, 2005, the Nagaland Information Commission had, vide letter No. S&A: UIIC CRO: NET: 2016/119 dated 25.05.2017 received a second appeal from Shri. Devinder Sharma, Krishna Cottage, 27-D, Dayal Bagh, Ambala Cantt. 133001 (HR), Mobile No.9876140198, email: sharmadevinder1953@gmail.com against the non-response by the Transport Commissioner & First Appellate Authority, Motor Vehicles Department, Nagaland, Kohima to his first appeal.

AND WHEREAS, on receipt of the above second appeal, the Commission had, vide letter of even No. dated 28.08.2017 issued directive to the Transport Commissioner & FAA, Motor Vehicles Department, Nagaland, Kohima to hear the first appeal in the presence of the PIO and the applicant (now appellant) since the first appeal was not heard by the First Appellate Authority.

AND WHEREAS, in compliance to the directive of the Commission, the Transport Commissioner & FAA, Motor Vehicles Department, Nagaland, Kohima had, vide letter No. TC/ESTT-RTI/APPEAL/302/2017/5353 dated 28.09.2017 submitted that the first appeal was heard by the First Appellate Authority on 05.05.2017 at 2:00 P.M and observed that since the driving license holder, Shri. Pratap Singh had personally appeared before the RTO & PIO, Mokokchung for conversion of his Driving license to Sarathi vide No. NL0220090018405 and since the information had already been furnished to the applicant (now appellant) vide letter No. RTO-MKG/RTI/G-30/08/6739 dated 15.11.2016, the Transport Commissioner & FAA had passed its decision and had closed the case vide letter No. TC/ESTT-RTI/APPEAL/302/2014 (165)/3001-03 dated 16.05.2017.

AND WHEREAS, since the information had already been furnished to the applicant (now appellant) vide letter No. RTO-MKG/RTI/G-30/08/6739 dated 15.11.2016 and since the Transport Commissioner & FAA, Motor Vehicles Department, Nagaland, Kohima had already heard the appeal case and closed the case, the Commission had also decided to declare this appeal case as closed.
