Subject: Closing Order of Appeal Case.

WHEREAS, under section 19 of the Right to Information Act, 2005 and in accordance to the Nagaland State Information Commission (Appeal Procedure) Rules, 2005, Shri. Vikheto Zhimomi, RTI Activist, P.R. Hill, Kohima, Mobile No. 9089896123/9615115300 had preferred second appeal dated 01.11.2016 before the Nagaland Information Commission against the non-response of the First Appellate Authority to his first appeal dated 05.09.2016 which was submitted against the unsatisfactory information furnished by the PIO in response to his RTI application dated 20.06.2016.

AND WHEREAS, on receipt of the second appeal dated 01.11.2016, the Commission had heard the appeal case on 17.01.2017 at 12:00 P.M and 12.09.2017 at 12:00 P.M.

AND WHEREAS, after the second hearing on 12.09.2017 at 12:00 P.M, the Commission had passed decision vide even No. dated 22.09.2017, wherein penalty for twenty two (22) days of delay @ ` 250.00 per day amounting to a total of ` 5500.00 (Rupees five thousand five hundred only) was imposed on Shri. Razouseyi Vese, Addl. Director & PIO, Directorate of School Education, Nagaland for contributing to the delay in furnishing the information to the applicant (now appellant).

AND WHEREAS, in compliance to the decision of the Commission of even No. dated 22.09.2017, Shri. Razouseyi Vese, Addl. Director & PIO, Directorate of School Education, Nagaland had deposited the penalty amount of ` 5500.00 (Rupees five thousand five hundred only) vide Treasury Challan No. 5 dated 06.10.2017 and a copy of the Treasury Challan submitted to this Commission.

AND WHEREAS, since the above Treasury Challan has been received, the Commission has decided to close this appeal case.

NOW THEREFORE, it is notified to all the parties that the appeal case is hereby declared as **closed.**
