

**Subject:** Closing Order of Appeal case.

WHEREAS under Section 19 of the Right to Information Act, 2005, and in accordance to the Nagaland State Information Commission (Appeal Procedure) Rules, 2005, the Commission had heard the second appeal dated 18.04.2016 received from Shri. Vinoka Aye, Consumer Society Dimapur, Top Floor 2/3, Millennium Building, Near Durga Mandir, Dimapur, Nagaland – 797112, Mobile No. 8974156706/ 9089289020, wherein the applicant stated that in response to his First Appeal dated 23.03.2016 which was submitted against the incomplete, false and misleading information received from the PIO in reply to his RTI application dated 15.02.2016, the Director & First Appellate Authority, Food & Civil Supplies, Nagaland, Dimapur had denied to furnish him the information sought and has misinterpreted his First Appeal dated 23.03.2016 stating that his RTI application dated 15.02.2016 was not specific and that he had applied for information pertaining to only Dimapur district.

AND WHEREAS, the Commission had, after hearing the appeal case on 07.06.2016 at 11:00 AM passed decision dated 30.06.2016.

AND WHEREAS, in compliance to the decision of the Commission dated 30.06.2016, Smti. Sentirenla Longkumer, Joint Director & PIO had, vide letter No. DSE/RTI-1/2015-16/476 dated 03.08.2016 informed the applicant (now appellant) for the inspection of records of PDS items for each of the 11 districts from 8<sup>th</sup> to 12<sup>th</sup> August 2016 and to collect the Utilisation Certificates after the completion of the inspection of records.

AND WHEREAS, also in compliance to the decision of the Commission dated 30.06.2016, Smti. Sentirenla Longkumer, Joint Director & PIO had, vide letter No. DSE/RTI-1/2015-16/593 dated 12.08.2016 informed the applicant (now appellant) that the information was ready and also to collect the Utilisation Certificates of all the PDCs from April 2013 to Feb. 2016 after the inspection of the Issue Registers was done.

AND WHEREAS, the Director & FAA had, vide letter No. DSE/RTI-1/2015-16/602 dated 18.08.2016 informed the Commission that the applicant (now appellant) had, from 8<sup>th</sup> to 12<sup>th</sup> August 2016 inspected the records pertaining to **query Nos. 1, 5 and 7** of the RTI application i.e. relating to Issue Registers of PDS items for all the schemes and for all the districts, and also that the Utilisation Certificates of all PDS items from April 2013 to Feb 2016 had been furnished. Further, the FAA informed that the applicant (now appellant) was satisfied with the records maintained by the public authority.

AND WHEREAS, since the Director & FAA and the PIO had complied with all the decisions of the Commission dated 30.06.2016, and that the applicant (now appellant) had also expressed satisfaction with the information and the inspection, the Commission had decided to close the appeal case.
