Sub: Closing Order of Appeal Case.

WHEREAS, under Section 19 of the RTI Act, 2005 and in accordance to the Nagaland Sate Information Commission (Appeal Procedure) Rules 2005, the Commission had, on 10.04.2018 at 12:00 Noon heard the Second Appeal dated 05.09.2017 submitted by Shri. Vilhousielie Kengurüse, President, Nagaland Pradesh Youth Congress (NPYC), Nagaland, Kohima-797001, Mobile No. 9774037529 and Shri. Limayangba, General Secretary (Adm.) Nagaland Pradesh Youth Congress (NPYC), Nagaland, Kohima-797001, Mobile No. 9862338667 against the non-satisfaction of the information furnished to them in response to their first appeal dated 06.07.2017 and which was submitted against the non-furnishing of information to their RTI application dated 26.05.2017.

AND WHEREAS, after the hearing on 10.04.2018 at 12:00 Noon, the Commission had passed decision of even No. dated 20.04.2018.

AND WHEREAS, in compliance to the <u>Point No.1</u> of the decision of the Commission dated 20.04.2018, Er. Rokozhalie Angami, Chief Engineer (T&G) & PIO, O/o the Engineer-in-Chief of Power, Nagaland, Kohima had, vide letter No.ENCP/E-342/Pt-I/2078 dated 15.05.2018 submitted the chronological order in writing and explaining that the main reason for the shifting of the project site for construction of 220/132/33KV sub-station from Chiephobouzou to Zhadima was due to the fact that the land acquired at Chiephobozou became insufficient and inadequate for the sub-station with the inclusion of additional bays.

AND WHEREAS, in compliance to the <u>Point No.2</u> of the decision of the Commission dated 20.04.2018, Er. Rokozhalie Angami, Chief Engineer (T&G) & PIO, O/o the Engineer-in-Chief of Power, Nagaland, Kohima had, vide letter No.ENCP/E-342/Pt-I/2078 dated 15.05.2018 submitted the copy of the information which was furnished to the applicants (now appellants) vide letter No.ENCP/E-342/Pt-I/2077 dated 15.05.2018 giving 15 days to confirm satisfaction or non-satisfaction of the information, failing which the information be considered as satisfactory.

AND WHEREAS, Er. Rokozhalie Angami, PIO, O/o the Engineer-in-Chief (Power), Nagaland, Kohima had, vide letter No.ENCP/E-342/Pt-I/2142 dated 27.06.2018 informed the Commission that the information has been furnished to the applicants (now appellants) giving 15 (Fifteen) days to respond for confirmation of satisfaction or non-satisfaction of the information, however, since the office have not received any reply from the applicant (now appellant) the case may be considered as closed.

AND WHEREAS, the Commission had, vide letter of even No. dated 18.08.2018 directed Er. Rokozhalie Angami, Chief Engineer (Transmission & Generation) & PIO, O/o the Chief Engineer-in-Chief of Power, Nagaland, Kohima to confirmed satisfaction or non-satisfaction of the information so furnished to the applicants (now appellants) within 2 weeks from the date of receipt of this directive.



AND WHEREAS, in compliance to the above Commission's directive dated 18.08.2018, Er. Rokozhalie Angami, PIO, O/o the Engineer-in-Chief of Power, Nagaland, Kohima had, vide letter No.ENCP/E-342/Pt-I/2195 dated 24.08.2018 submitted that the Office had already written to the applicants (now appellants) for confirmation of satisfaction or non-satisfaction vide T.O. letter No.ENCP/E-342/Pt-I/2142 dated 27.06.2018 and a copy of which was received by the Commission on 04.07.2018. Further, reiterating that since the office had not received any reply from the applicants (now appellants), the PIO has again requested that the case may be considered closed.

AND WHEREAS, since the above compliances have been received from the Public Authority and though sufficient time had lapsed and there was no response from the applicants (now appellants), suggesting that the applicants have no interest to pursue further the case, the Commission has decided to close the appeal case.

NOW THEREFORE, it is notified to all the parties that this appeal case is hereby declared as **closed**:-
