Keluozie Kesiezie, Assistant Administrative Officer & PIO, The Global Open University Nagaland, Dimapur had, vide letter No.GOUN/2-14/16A VOL-II/484 dated 15.02.2019 submitted a copy of Treasury Challan No.13 dated 14.02.2019 for the penalty amount of `4500/- for contributing to the delay of 18 days, imposed on him in furnishing the information to the applicant (now appellant).
