Yapang Lkr, s/o Samalempa Lkr, Mobile No.9612800973/ 9856714829, RTI Initiative Nagaland, C/o Longkumer Shop, House No.JS 186, Lower Jail Colony, Near Assamese Church, Kohima-797001, Nagaland against the non-response of the Principal Director & FAA, Directorate of Health & Family Welfare, Nagaland, Kohima to their first appeal No.RTI/No-43/S&O/H&F-3 dated 29.08.2018 (but signed on 20.08.2018) which was submitted against the non-response of Dr.W.Punsokio Yimchunger, Additional Director & PIO, Directorate of Health & Family Welfare, Nagaland, Kohima to their RTI application dated 05.07.2018.

AND WHEREAS, the applicants, Shri. Odi Jamir and Shri. S.T. AND WHEREAS, on receipt of the RTI application dated 05.07.2018 on 06.07.2018, Dr. W. Punsokio Yimchunger, Additional Director & PIO, Directorate of Health & Family Welfare, Nagaland, Kohima had, vide letter No.DHFW-19/RTI/05/2017-18/3745-48 dated 06.07.2018 **transferred the RTI application** to the following State Programme Officers of the Directorate of Health & Family Welfare, Nagaland, Kohima to furnish the relevant information directly to the applicant (now appellant) under intimation to him:-

AND WHEREAS, on receipt of the above letter No.DHFW-19/RTI/05/2017-18/3745-48 dated 06.07.2018, Dr. Kevichusa Medikhru, Mission Director, State Health Society, National Health Mission, Department of Health & Family Welfare, Nagaland, Kohima had, vide letter No.NRHM/NL-15/37/Part-B/2016-17/00682 dated 17.07.2018 further **transferred the RTI application** to the PIO, District Health Society, C/o Chief Medical Officer, Mokokchung, Nagaland to take necessary actions as per provision of RTI rules.

AND WHEREAS, on not getting any response to their RTI application dated 05.07.2018, the applicants (now appellants) had, vide letter No.RTI/No.43/S&O/H&F-3 dated 29.08.2018 (but signed on 20.08.2018) submitted a first appeal to the Principal Director & FAA, Health & Family Welfare, Nagaland, Kohima.

AND WHEREAS, on receipt of the above first appeal dated 29.08.2018 on 29.08.2018, Dr.Vikeyie Losur, Principal Director & FAA, Health & Family Welfare, Nagaland, Kohima had, vide letter No.DHFW-19/RTI/05/2017-18/4368 dated 04.09.2018 (but signed on 31.08.2018) **transferred the first appeal** to the following Sate Programme Officers of the Directorate of Health & Family Welfare, Nagaland, Kohima directing them to furnish the complete information to the applicants (now appellants) within a time limit and without any cost, and to submit a statement on how the RTI application had been delayed:-

- 1.The State Programme Officer (NHM) & PIO,
- 2.The State Programme Officer (RCH) & PIO and
- 3.The State Programme Officer (UIP) & PIO

AND WHEREAS, on receipt of the above letter, Dr.Atoshe Sema, SPO, UIP, Directorate of Health & Family Welfare, Nagaland, Kohima had, vide letter No.DHFW-16/UIP/RTI/34/2018-19/523-524 dated 05.09.2018 informed the Principal Director, Health & Family Welfare, Nagaland, Kohima that the information sought by Shri. Odi Jamir and Shri. S.T. Yapang Lkr had been provided to the Mission Director, National Health Mission by Dr.Visasieu Kire, State Immunization Officer (UIP), Nagaland, Kohima vide letter No.DHFW-16/UIP/RTI/34/2018-19/295 dated 17.07.2018 stating that the RTI information sought by the applicants (now appellants) was for the distrcit of Mokokchung and that though the funds were utilized/ released from the State level, the actual expendiure/ implementation was incurred at the district level. He further stated that since the details of expenditure sought in the RTI application would be available in the District level, the RTI application had to be transferred to the Chief Medical Officer, Mokokchung.

AND WHEREAS, since the applicants (now appellants) had not received the full information as sought, the Commission has decided to hear the appeal case giving opportunity of being heard to all the parties on **15th February, 2019 (Friday) at 12:00 Noon** in the **Hearing Room of Nagaland Information Commission, below Raj Bhavan, Officers' Hill Colony, Nagaland, Kohima.**
