WHEREAS under Section 19 of the Right to Information Act, 2005 and in accordance to the Nagaland State Information Commission (Appeal Procedure) Rules, 2005, the Commission had heard the second appeal dated **03.11.2016** for the <u>second time</u> on 05.09.2017 at 11:00 AM which was submitted by Shri. Vikheto Zhimomi, RTI Activist, P.R. Hill Kohima, Mobile No. 9089896123 against the non- satisfaction of information furnished in response to his RTI application dated 22.06.2016 by the PIO, Office of the Chief Engineer, PHED, Nagaland and to his subsequent first appeal dated 26.08.2016 submitted to the First Appellate Authority, Office of the Chief Engineer, PHED, Nagaland, Kohima.

AND WHEREAS, the Commission had, after the second hearing held on 05.09.2017 at 11:00 AM passed its decision vide even No. dated 21.09.2017 directing the Executive Engineers of Mokokchung and Peren to submit compliance within two (2) weeks from the date of issue of the Decision, with a copy to the Commission.

AND WHEREAS, on not getting any response or compliance to its decision dated 21.09.2017, the Commission had, vide directive of even No. dated 08.11.2017 directed the Addl. Chief Engineer & PIO, PHED to submit compliance within two (2) weeks from the date of issue of the Decision.

AND WHEREAS, Er. Repangyangba Longkumer, Addl. Chief Engineer & PIO, O/o the Chief Engineer, PHED, Nagaland, Kohima had, vide letter No. CE/PHE/M/RTI/2006-07/31-33 dated 16.11.2017 submitted to the Commission stating that the two defaulting Divisions i.e. Mokokchung and Peren had already complied to the Decision of the Commission, and had enclosed copies of the compliance reports submitted to the Addl. Chief Engineer & PIO, O/o the Chief Engineer, PHED, Nagaland, Kohima by the Executive Engineer & PIO, PHED Peren Division, Peren, Nagaland vide letter No. EE/PHE/PRN/RTI/2016-17 dated NIL in compliance to Point No. 1 of the decision of the Commission, and also by the Executive Engineer & PIO, PHED, Mokokchung, Nagaland vide letter No. EE/PHE/MKG/RTI/2007-08 dated 19.10.2017 in compliance to Point No. 2 of the decision of the Commission.

AND WHEREAS, the applicant (now appellant) had, vide letter dated NIL submitted to the Commission stating that he had received **satisfactory information** from the PHED and hence requested the Commission to close the case.
