- 1. Furnish Xerox copy of DPR/estimate of the Project.*
- 2. Furnish detail of the fund release till date against the project.*
- 3. Furnish in detail as to why the location of the project has been relocated. (enclosed relevant documents).*
- 4. Furnish in detail the progress of the project on percentage basis.*

AND WHEREAS, on not getting any response to their RTI application dated **26.05.2017**, the applicants had submitted a first appeal dated **06.07.2017** to the First Appellate Authority, Power Department, Nagaland, Kohima.

AND WHEREAS, in response to the first appeal dated **06.07.2017**, Er. Rokozhalie Angami, PIO, O/o the Engineer-in-Chief, Department of Power, Nagaland, Kohima had, vide letter No. ENCP/PIO/RTI-1/05-06/1537 dated 17.07.2017 furnished the information to the applicant (now appellants).

AND WHEREAS, on not being satisfied with the information furnished to them by the PIO, O/o the Engineer-in-Chief, Department of Power, Nagaland in response to their first appeal, the applicants (now appellant) had, vide letter dated 05.09.2017 submitted a second appeal to this Commission.

AND WHEREAS, the Commission has decided to hear the appeal giving opportunity of being heard to the parties on **16th February, 2018 (Friday) at 12:00 P.M** in the **Hearing Room of Nagaland Information Commission, Below Raj Bhavan, Officers' Hill Colony, Nagaland, Kohima.**
