WHEREAS, under Section 19 of the RTI Act, 2005, the Commission had received a second appeal dated 27.07.2016 transferred from the Central Information Commission vide Diary No. 163872/2016 dated 22.11.2016 which was preferred by Shri. Mahindra Nath Jha, Qtr No. D-29/2, BRBNMPL SALBONI, West Bengal, 721132, Mobile No. 9476247188, email: capt.mnjha@rediffmail.com against the non-response of the Director/Registrar & First Appellate Authority, to his first appeal dated 20.04.2016 which was submitted against the non-response of the PIO, The Global Open University Nagaland and to his RTI application dated 08.02.2016.

AND WHEREAS, the applicant, Shri. Mahindra Nath Jha had earlier submitted an RTI application dated 08.02.2016 along with the prescribed application fee of `10/- paid through demand draft seeking the following information pertaining to his Roll No. TGOUN/NLII/038/LLM/2012J:

- 2. A copy of my mark sheet and Pass Certificate.

AND WHEREAS, on not getting any response to his RTI application dated 08.02.2016, the applicant submitted a first appeal dated 20.04.2016 addressed to the First Appellate Authority, The Global Open University Nagaland.

AND WHEREAS, on not getting any response to his first appeal dated 20.04.2016 within the stipulated time period of 30 (Thirty) days, the applicant had preferred a second appeal dated 27.07.2016 before the Central Information Commission, New Delhi, however, the second appeal was transferred to this Commission vide Diary No. 163872/2016 dated 22.11.2016 as the matter pertains to this Commission.

AND WHEREAS, on receipt of the second appeal dated 27.07.2016, since the First Appeal was not heard, the Commission had, vide letter of even No. dated 28.08.2017 directed the First Appellate Authority to take up the first appeal by hearing the parties i.e, the applicant and the PIO concerned and pass decision within 1 (one) month from the date of receipt of the directive and submit a copy of the decision to this Commission.

AND WHEREAS, the applicant (now appellant), Shri. Mahindra Nath Jha had vide letter dated 14.09.2017 requested the Commission to close the appeal case since the Public Authority had, vide No. GOUN/EX/6-13/16/A/20H dated 10.07.2017 furnished the information sought by him.

AND WHEREAS, since there was no compliance to the directive of the Commission of even No. dated 28.08.2017 from the First Appellate Authority, The Global Open University Nagaland and also that there was delay in furnishing the information to the applicant (now appellant), the Commission has decided to hear the appeal case again giving opportunity to the
