AND WHEREAS, in response to the letter issued by the District Transport Officer & PIO, Motor Vehicles Department, Zunheboto, Nagaland vide No. DTO/ZBTO/RTI-05/2017-18/377 dated 05.09.2017, the applicant (now appellant) had, vide letter No. 2014215744/SIC/Nagaland dated 13.09.2017 submitted non-satisfaction stating that he was confused as there were two contradictory information furnished in respect of the same Driving License. The information furnished to him vide No. DTO-Z/RTIACT-05/2016-17/296 dated 05.10.2016 by the APIO & Motor Vehicle Inspector Office of the District Transport Officer, Zunheboto, Nagaland stated that the driving license No. 6075/NTV/2011 was fake and bogus whereas in another reply given by the DTO & PIO, Zunheboto vide No. DTO-Z/RTI ACT-05/2012/869 dated 04.07.2015 to an applicant, Shri. Sachin Gulati, H/No-224, Guru Nanakpura, Jagadhri, Haryana, it was mentioned as genuine.

AND WHEREAS, the DTO & PIO, Zunheboto had, vide letter No. DTO-Z/RTI ACT-05/2017-18/391 dated 11.10.2017 addressed to the applicant (now appellant), Shri. Narinder Kumar and No. DTO-Z/RTI ACT-05/2017-18/388 dated 11.10.2017 addressed to Shri. Sachin Gulati had clarified that due to clerical oversight the report given to Shri. Sachin Gulati was mentioned as verified and found genuine, however, it should be **read as verified and not found genuine** as per office record.

AND WHEREAS, the Commission has decided to hear the case again giving opportunity of being heard to the parties on 16th November (Thursday), 2017 at 11:00 A.M in the Hearing Room of Nagaland information Commission, Below Raj Bhavan, Officers' Hill Colony, Nagaland, Kohima.
