WHEREAS, the applicant, Shri. Renet had earlier submitted an RTI application vide letter No.NIL dated 06.04.2017 addressed to the PIO, Irrigation and Flood Control (now Water Resources), Jalukie, Peren, Nagaland along with application fee of Rs.10/- seeking the following information:-

- 1. Kindly provide the details of work taken up in Peren district under Accelerated Irrigation Benefits Programme (AIBP) with project report and financial report of each individual project?
- 2. *Kindly provide details of individual to whom the work was allocated under AIBP in Peren district?*
- 3. Kindly Provide the details of work taken up in Peren under Flood Management Programme with project reports and financial report of each individual project?
- 4. Kindly provide the details of work taken up in Peren district under Command Area Development and Water Managment Programme with project reports and financial report of each individual project?
- 5. Kindly provide the details of work taken up in Peren district under Hydrology Programme with project reports and financial report of each individual project?
- 6. Kindly provide the details of work taken up in Peren district under North East Council (Non-Lapsable Central Pool of resources) with project reports and financial report of each individual project?

AND WHEREAS, the above RTI application dated 06.04.2017 was received by the Surveyor on the same day as evidenced on the body of the said application addressed to the PIO, Irrigation and Flood Control (now Water Resources), Jalukie, Peren, Nagaland.

AND WHEREAS, the Chief Engineer & FAA, Irrigation & Flood Control, Nagaland, Kohima had on 25.05.2017 received a first appeal from the applicant which was sent by speed post bearing No. EE459892082IN. However, a copy of the first appeal was not enclosed.

AND WHEREAS, on receipt of the second appeal, since the first appeal was not found enclosed by the applicant (now appellant), the Commission had through e-mail dated 26.09.2018 asked the applicant (now appellant) to submit a copy of the first appeal addressed to the Chief Engineer, Irrigation & Flood Control Department (now Water Resources Department), Nagaland, Kohima.

AND WHEREAS, on receipt of the e-mail, the applicant (now appellant) had, through e-mail submitted that he could get the speed post tracking No.EE459892082IN which was received by the Chief Engineer Office Irrigation and Flood Control, Nagaland, Kohima on 25.05.2017 and the information furnished on 13.06.2017.

AND WHEREAS, the Chief Engineer, Irrigation and Flood Control (now Water Resources), Nagaland, Kohima had, vide letter No.IFC-RTI-TECH/Case No.1/2017-18/889-90 dated 13.06.2017 furnished the information to the applicant and with a copy to the Under Secretary to the Govt. of Nagaland, Irrigation & Flood Control Department (now Water Resources Department), Nagaland, Kohima.

AND WHEREAS, on receipt of the above information on 13.06.2017 from the Chief Engineer, Irrigation and Flood Control, Nagaland, Kohima, the applicant had submitted a second appeal dated 08.08.2018 before the Commission stating that he was not satisfied with the information since the information provided to him was not true and did not match with the actual projects sanctioned.

AND WHEREAS, since the applicant (now appellant) was not satisfied with the delayed information furnished by the Chief Engineer & FAA, the Commission has decided to hear the appeal case giving opportunity of being heard to all the parties on <u>16th October, 2018 (Tuesday) at 1:00</u> <u>P.M.</u> in the <u>Hearing Room of Nagaland Information Commission, below Raj Bhavan, Officers'</u> <u>Hill Colony, Nagaland, Kohima</u>.
