Subject: Notice for Hearing on 15th March (Thursday), 2018 at 12:00 P.M.

WHEREAS, under Section 18 of the RTI Act, 2005, the Commission had received a complaint dated **21.09.2017** from Shri. Akavi Sumi, House No. 168, Lower Forest Colony, Kohima, Nagaland, Mobile No. 9402403339/7105321808 against unsatisfactory and late response from the PIO, Nagaland State Disaster Management Authority, Home Department, Nagaland, Kohima to his RTI application dated 21.06.2017.

AND WHEREAS, the applicant had earlier submitted an RTI application dated **21.06.2017** addressed to the PIO, Home Department, Natural Calamities & Disaster Management Authority, Kohima, Nagaland along with the prescribed application fee of Rs. 10/- in cash seeking the following information:-

- i. *The sanction accord from the ministry since 2010 till date (i.e. 21/06/2017) for the State of Nagaland (year wise).*
- ii. *The sub allocation of works and amounts placed under respective districts and name of the Contractor/Firms.*
- iii. *The nature of works and completion of work's certificate with enclosed photos, mentioning the location of works.*
- iv. *All the ongoing works and newly projected works be furnished with all required documents details.*

AND WHEREAS, on not getting any response to his RTI application dated 21.06.2017 from the PIO, Nagaland State Disaster Management Authority, Home Department, Nagaland even after the lapse of the prescribed period of thirty (30) days, the applicant had submitted a letter dated **21.08.2017** to the PIO reminding to furnish the information, as the RTI application dated 21.06.2017 was handed over personally and there was no response for the past two (2) months.

AND WHEREAS, the Commissioner & Secretary & PIO, Nagaland State Disaster Management Authority-Home Department, Nagaland, Kohima had, vide letter No. NSDMA/RTI/2011(Pt-1)/904 dated **29.08.2017** furnished the information to the applicant.

AND WHEREAS, on not being satisfied with the information furnished to him, the applicant had submitted a complaint dated 21.09.2017 to this Commission, stating that all the queries answered were **misleading** and that the Department had responded only after submission of his supplementary letter dated 21.08.2017.

AND WHEREAS, the Commission has decided to hear the Complaint giving opportunity of being heard to all the parties on **15th March (Thursday), 2018 at 12:00 P.M** in the **Hearing Room of Nagaland Information Commission, Below Raj Bhavan, Officers' Hill Colony, Nagaland, Kohima.**
