- iv. All the ongoing works and newly projected works be furnished with all required documents details.

AND WHEREAS, on not getting any response to his RTI application dated 21.06.2017 from the PIO, Nagaland State Disaster Management Authority, Home Department, Nagalandeven after the lapse of the prescribed period of thirty (30) days, the applicant had submitted a letter dated  $\underline{21.08.2017}$  to the PIO reminding to furnish the information, as the RTI application dated 21.06.2017 was handed over personally and there was no response for the past two (2) months.
