Subject: Closing of appeal case.

WHEREAS under Section 19(10) of the Right to Information Act, 2005, and in accordance to the Nagaland State Information Commission (Appeal Procedure) Rules, 2005, the Nagaland Information Commission had heard the appeal case dated 15.11.2012 from an appellant, Namsung Phom, S.A, Civil Secretariat, Higher & Technical Education Department, Nagaland, Kohima & two (2) others against the non-response or decision of the Director & First Appellate Authority, Rural Development, Nagaland, Kohima to the first appeal dated 08.10.2012;

AND WHEREAS the Commission had, after hearing both the parties, passed decision on the appeal case on 15.01.2013;

AND WHEREAS in compliance to the decision of the Commission dated 15.01.2013, Mrs Imnukshila Jamir, Project Director, DRDA, Longleng, had vide letter No. DRDA/LLG/RTI-1/13 dated 08.03.2013 paid the full penalty amount for Rs. 25,000.00 (Rupees twenty five thousand only) in two equal instalments of Rs. 12,500.00 vide Challan No. 4 dated 07.02.2013 and Challan No. 1 dated 01.03.2013.

AND WHEREAS in compliance to the decision of the Commission dated 15.01.2013 and subsequent reminder letter of even No. dated 08.04.2013, the Project Director & PIO, DRDA, Longleng had, vide letter No. DRDA/LLG/RTI-1/13 dated 26.04.2013 provided the complete information to the appellant.

AND WHEREAS there is no further complain from the appellant even after more than three (3) months had elapsed, suggesting that the information so received was satisfactory;

AND WHEREAS the Commission had decided to declare the case closed.
