**Subject: Closing of appeal case.**

WHEREAS under Section 19 of the Right to Information Act, 2005, the Nagaland Information Commission had received Second Appeal letter No. LCS&RTI/12-13/26 dated 04.01.2013 from Shri. Khekuto Tuccu, President, Life Consumer Society & RTI, Super Market Complex, OB-30, Dimapur, Nagaland – 797112, stating that he was not satisfied with the reply of the Commissioner & Secretary and FAA, Department of Food and Civil Supplies, Nagaland, Kohima to his first appeal vide No. LCS&RTI/12-13/21 dated 02.11.2012 which was submitted against the unsatisfactory and incomplete reply of the PIO to his RTI application vide No. LCS&RTI/2012-13/13 dated 29.08.2012.

AND WHEREAS earlier, the applicant had, vide RTI application letter No. LCS&RTI/2012-13/13 dated 29.08.2012, addressed to the PIO, Office of the Secretary to the Govt. of Nagaland, Department of Food & Civil Supplies, Nagaland, Kohima and enclosed an application fee of Rs. 10/-, seeking information on 23 (twenty three) queries.

AND WHEREAS, the Additional Secretary & PIO, Department of Food and Civil Supplies, Nagaland, Kohima had, vide letter No. SPLY-1/20/2012(Pt-1) dated 9.10.2012 informed the applicant that the information was ready and to collect the same from his office during office hours on payment of Rs. 52/- (Rupees fifty two only) being the cost of paper @ of Rs. 2/- per page under Section 7 of the RTI Act, read Rule 4(a) of the Nagaland State RTI(Regulation of fees & cost) Rules, 2005.

AND WHEREAS, the applicant submitted first appeal vide No. LCS&RTI/12-13/21 dated 02.11.2012, stating that the reply of the Additional Secretary & PIO, Department of Food and Civil Supplies, Nagaland, Kohima for Sl. No. 2, 5, 8, 9 & 10 were unsatisfactory and incomplete.

AND WHEREAS, in response to the first appeal dated 02.11.2012, the Commissioner & Secretary and FAA, Department of Food and Civil Supplies, Nagaland, Kohima had, vide letter No. SPLY-1/20/2012(Pt-1) dated 4.12.2012 informed the applicant (now appellant) that the information sought was ready and enclosed as Annexure-I, and therefore requested to come and collect the information during office hours.

AND WHEREAS, on receipt of the second appeal vide No. LCS&RTI/12-13/26 dated 04.01.2013, the Commission had, vide its letter of even No. dated 01.04.2013, directed the applicant (now appellant) to specify and clearly spell out the grounds for non-satisfaction of the replies for Sl. No. 2, 5, 8, 9 & 10, latest **by 12.04.2013** positively, since the information were already given by the Additional Secretary & PIO, Department of Food and Civil Supplies, Nagaland, Kohima and also subsequently by the Commissioner & Secretary and FAA, Department of Food and Civil Supplies, Nagaland, Kohima.

AND WHEREAS there is no response or further complain from the appellant even after sufficient time had elapsed, suggesting that the information so received was satisfactory;

AND WHEREAS the Commission had decided to declare the case closed.

NOW THEREFORE, it is notified to the following parties that the appeal case is hereby declared closed:-
