## Subject: Closing of appeal case.

WHEREAS under Section 19 of the Right to Information Act, 2005 and the Nagaland State Information Commission (Appeal Procedure) Rules, 2005, the Nagaland Information Commission had, on 09.04.2013 and 11.06.2013 heard the second appeal dated 29.01.2013 submitted by an appellant, Jagdev, S/o Surat Singh, R/o Vill. Seidpur Tehsil, Kharkhoda District, Sonepat, Haryana, wherein the applicant (now appellant) stated that he did not receive any response from the Deputy Commissioner & FAA, Office of the Deputy Commissioner, Dimapur, Nagaland to his first appeal dated NIL which was submitted against the non-response of the Addl. Deputy Commissioner & PIO, Office of the Deputy Commissioner, Dimapur, Nagaland to his RTI application dated 07.11.2012.

AND WHEREAS, the Commission had, after hearing the parties, passed decisions of even No. dated 25.04.2013 and 06.07.2013;

AND WHEREAS, in compliance to the Commission's Decision dated 06.07.2013, the Office of the Deputy Commissioner, Dimapur, Nagaland had, vide letter No. RTI-4/2012-D/7756-57 dated 03.09.2013 informed the Commission about the payment of the penalty fine imposed on Shri. Tarep Imchen, Addl. Deputy Commissioner & PIO, Office of the Deputy Commissioner, Dimapur, Nagaland amounting to Rs. 9000.00 (Rupees nine thousand only), vide Treasury Challan No. 95 dated 29.07.2013 in single instalment.

AND WHEREAS, the Commission observed that the information had been furnished to the applicant(now appellant), though belatedly, and that the above decision/directives are complied with by the Addl. Deputy Commissioner & PIO, Office of the Deputy Commissioner, Dimapur, Nagaland;

AND WHEREAS, as decided at Point No. 5 in its decision dated 06.07.2013, the Commission observed that since sufficient time had lapsed, there was no response or complaint received from the applicant(now appellant), suggesting that the applicant was satisfied with the information so provided and that the applicant has no interest to pursue the case further, the Commission decided to declare the case closed.
