Subject: Closing of appeal case.

WHEREAS under Section 19(10) of the Right to Information Act, 2005, and in accordance to the Nagaland State Information Commission (Appeal Procedure) Rules, 2005, the Nagaland Information Commission had, on 29.06.2012 heard the second appeal dated 26.04.2012 submitted by an appellant, Mr. Joshua Sheqi, Advocate, Gauhati High Court, Kohima Bench, Kohima, Nagaland, Mobile: 9856235997, against the non-response or decision from the Director & First Appellate Authority, Health & Family Welfare, Nagaland, Kohima to his first appeal dated 14.02.2012;

AND WHEREAS the Commission had, after hearing both the parties, passed decision on the appeal case on 29.06.2012;

AND WHEREAS, in compliance to point No. 1 of the decision of the Commission of even No. dated 29.06.2012, the Principal Director & First Appellate Authority, Health & Family Welfare, Nagaland, Kohima had submitted the inquiry report to the Commission vide letter No. DHFW-19/RTI/31/2012/8848 dated 02.08.2012;

AND WHEREAS, in compliance to point No. 2 of the decision of the Commission of even No. dated 29.06.2012, the information was furnished to the appellant vide letter No. 19/RTI/31/2012/9079-81 dated 09.08.2012;

AND WHEREAS the appellant had, vide letter No. Nil dated 18.08.2012 submitted that information so provided by the Directorate of Health & Family Welfare vide No. 19/RTI/31/2012/9079-81 dated 09.08.2012 in respect of Queries No. 4 and 5 were incomplete as it lacked documental proofs of ACP Scheme and benefits thereof accruable to the FHW/ANMs. The appellant had also questioned the competency of the Officer who furnished the replies which was signed by the Accounts Officer other than the FAA, thus reflecting the negligence of the FAA in carrying out the Commission's Decision Order, amounting to violation of the Commission's Decision Order.

AND WHEREAS the Commission had, vide letter of even No. dated 05.09.2012, directed the Principal Director & First Appellate Authority, Health & Family Welfare, Nagaland, Kohima to take the Commission's Decision Order seriously and furnish complete and factual information as sought by the applicant (now appellant) and to his satisfaction. Also a copy of the information so furnished be given to the Commission for its records.

AND WHEREAS, in compliance to the direction of the Commission of even No. dated 05.09.2012, the Principal Director & FAA Health & Family Welfare, Nagaland, Kohima had, vide letter No. DHFW-19/RTI/31/2012/11300-03 dated 20.09.2012 furnished the information to the appellant in respect of Queries No. 4 and 5 regarding ACP Scheme and

benefits thereof accruable to the FHW/ANMs, alongwith the Minutes of the Departmental Screening Committee Meeting on ACP Scheme;

AND WHEREAS there is no further complain from the appellant even though enough time has elapsed since the information was furnished to the appellant, suggesting that the information so received was satisfactory;

AND WHEREAS the Commission had decided to declare the case closed.

NOW THEREFORE, it is notified to the following parties that the appeal case is hereby declared closed:-
