WHEREAS under Section 19(3) of the Right to Information Act, 2005, the Nagaland Information Commission have received a second appeal dated 28.03.2012 from an appellant, Mr. Rügeisier of Assembled Organisation, C/o Advocate Chamber, NST Complex, 1st Floor, Kohima, against non-response or decision from the Director & First Appellate Authority, Rural Development, Nagaland, Kohima on his first appeal dated 04.02.2012;

AND WHEREAS the applicant had submitted his first appeal dated 04.02.2012 to the Director & First Appellate Authority, Rural Development, Nagaland, Kohima against the non-response of the Additional Director & PIO, Rural Development, Nagaland, Kohima within the stipulated time frame of 30 (thirty) days to the applicant's RTI request dated 12.12.2011, seeking information on 5 (five) queries;

AND WHEREAS the Additional Director & PIO, Rural Development, Nagaland, Kohima had provided the information vide letter No. DRD/RTI-14/06(Pt) dated 6.03.2012 **free of cost** to the applicant (now appellant) after a lapse of one month of submission of his first appeal dated 04.02.2012, stating that the delay was due to the fact that the required information had to be obtained from the district/block and village levels. And the applicant (now appellant) had received the information on 09.03.2012, however, the appellant alleges that the information received was **incomplete as two queries out of the five queries were not provided**.

AND WHEREAS the Nagaland Information Commission has decided to hear the appeal, giving opportunity to the parties on 23^{rd} May, 2012 (Wednesday) at 02:00 PM in the Hearing Room of the Nagaland Information Commission, Old Secretariat Complex, Kohima.
