## Subject: Seeking information under the RTI Act, 2005.

Sir,

I am directed to refer to an appeal dated 13.09.2012 (copy enclosed) received from Peina Ndang, C/o The GMTD BSNL Super Market Complex, Dimapur, Nagaland, Mobile No. 9402832636 wherein the applicant (now appellant) stated that no information has been received to his RTI application dated 11.07.2012 submitted to the Addl. Director & PIO, Food & Civil Supplies, Nagaland, Dimapur and even after filing first appeal dated 23.08.2012 to the Director & First Appellate Authority (FAA), Food & Civil Supplies, Nagaland, Dimapur.

The Addl. Director & PIO, Food & Civil Supplies, Nagaland, Dimapur had vide letter No. DSE/RTI-1/2012-13/747 dated 16.07.2012 stated that since the information was not available in the Directorate she had forwarded the RTI application dated 11.07.2012 to the Commissioner & Secretary, Department of Food & Civil Supplies, Nagaland, Kohima.

On not receiving any information from the Addl. Director & PIO, Food & Civil Supplies, Nagaland, Dimapur within the stipulated time, a first appeal dated 23.08.2012 was submitted to the Director & FAA, Food & Civil Supplies, Nagaland, Dimapur. And the Director & FAA, Food & Civil Supplies, Nagaland, Dimapur in reply to the first appeal dated 23.08.2012 informed the applicant (now appellant) reiterating that the RTI application dated 11.07.2012 was forwarded to the Commissioner & Secretary, Department of Food & Civil Supplies, Nagaland, Kohima since information was not available in the Directorate but in the Secretariat vide No. DSE/RTI-1/2012-13/1030 dated 29.08.2012.

It is, therefore, requested kindly to inform the Commission as to whether the information sought by the applicant (now appellant) has been furnished.

Also, in view of the above, the Commission directs that since first appeal has been filed, the Director & FAA, Food & Civil Supplies, Nagaland, Dimapur should hear the first appeal within 30 days from the date of receipt of this letter and a copy of the quasi-judicial decision be forwarded to this Commission.
