- ii. Construction of permanent HQ for 12 NAP (IR) BN at Longleng
- iii. Construction of permanent HQ for 13 NAP (IR) BN at Yachang
- iv. Construction of permanent HQ for 14 NAP (IR) BN at Kiphire
