Subject: Notice for hearing on 29th January, 2013 (Tuesday) at 02:00 PM.

WHEREAS under Section 19 of the Right to Information Act, 2005, the Nagaland Information Commission have received a second appeal dated 30.11.2012 from an appellant, Shri. Kezhokhoto Savi, Advocate & President, Nagaland Voluntary Consumer Organisation, C/o Kohima Law College, Raj Bhavan Road, Kohima-797001, Mobile – 9436209438, against the non-response of the Chief Engineer, PWD(R&B) & First Appellate Authority, Nagaland, Kohima to his first appeal dated 17.10.2012.

AND WHEREAS the applicant (now appellant) had submitted first appeal dated 17.10.2012 to the First Appellate Authority, Office of the Chief Engineer, PWD(R&B) Nagaland, Kohima against the non-response of the PIO, Office of the Chief Engineer, PWD(R&B), Nagaland, Kohima within the stipulated time frame to the applicant's RTI request dated 29.08.2012 which was submitted along with the prescribed application fee of Rs. 10/- in cash, requesting for documents relating to 11 (eleven) Nos of Bridge Projects under Special Package (SPA) for Eastern Nagaland i.e, 4 districts during 2012-13 namely:-

- (1) 7 Nos. of bridges on Mon-Tizit road 44.00 KM (ongoing works) Project cost Rs. 15340.26 lakhs.
- (2) Construction of bridge over Dikhu on Longleng-Chuchuyimlang road (Phase-I) Project Cost Rs. 2100.00 lakhs.
- (3) Construction of bridge over Dikhu on Longleng-Chuchuyimlang road (Phase-II) Project Cost Rs. 2000.00 lakhs.
- (4) Construction of 20 M long RCC bridge on Longleng Aboi road over Shiyong River Project Cost Rs. 3413.00 lakhs.
- (5) Construction of 20 M long RCC bridge over river Shesha on Longleng-Yongyah EAC Hqs. Yongyam-Nian road Project Cost Rs. 2811.00 lakhs.
- (6) Construction of RCC bridge over river Yongmon on Longleng-Angjangyang SDO (Civil) Hqs. Road (Phase –I) Project Cost Rs. 2954.00 lakhs.
- (7) Construction of RCC bridge over river Yongmon on Longleng-Angjangyang SDO (Civil) Hqs. Road (Phase –II) Project Cost Rs. 1999.83 lakhs.

Total 11 Nos bridges cost Rs. 30618.09 lakhs i.e, Rs.306.18 crores.

AND WHEREAS Er. V. Kehie, Addl. Chief Engineer, Office of the Chief Engineer, PWD (R&B), vide letter No. CE/R&B/RTI/CORR/2011-12 dated 27.09.2012 wrote to the applicant stating that the Department regrets and apologises for being unable to reply to the RTI queries on time due to some unavoidable circumstances and further requested to extend the time by 2 (two) weeks in order to enable the Department to furnish in detail.

AND WHEREAS the applicant (now appellant) also stated that the PIO, Office of the Chief Engineer, PWD (R&B), Nagaland, Kohima had furnished documents but it was incomplete in all projects as mentioned in the RTI application dated 29.08.2012 since the following documents could not be furnished by the PIO, Office of the Chief Engineer, PWD (R&B), Nagaland, Kohima:-

4. Govt. Sanction Order and Administrative approval.
5. Original NIT.
6. Newspaper clipping of the NIT published.
7. Original Tender Comparative Statement and BOQ.
8. Consultant appointment order payment upto 31st March 2012 alongwith bill vouchers.
9. All DA/DL issued by Finance Department.
10. Expenditure incurred up to date i.e, 31st March 2012 along with bill.
