## Subject: Order for closing of appeal case.

WHEREAS under Section 19 of the Right to Information Act, 2005, and in accordance to the Nagaland State Information Commission (Appeal Procedure) Rules, 2005, the Nagaland Information Commission had, on 19.03.2014 heard the Second Appeal dated 28.01.2014 received from an appellant, Shri. K. Thong, Member, Vigilance Cell, NPCC, Congress Bhavan, Kohima, Mobile No. 9612169565, against the non-response of the Director & FAA, Social Welfare, Nagaland to his first appeal dated 21.11.2013 which was subsequently submitted against the non-response of the PIO, Directorate of Social Welfare, Nagaland, Kohima to his RTI application dated 18.10.2013.

Merangtsungba Aier, Additional Director & PIO, Social Welfare, Nagaland, Kohima had, vide letter No. SW/RTI-6/2014/1629 dated 28.05.2014 informed that the penalty fine imposed on him for an amount of Rs. 23,500.00 (Rupees twenty three thousand and five hundred only) for the total cumulative delay of 94 (ninety four) days in furnishing the information to the applicant(now appellant), Shri. K. Thong, Member, Vigilance Cell, NPCC, Congress Bhavan, Kohima, Mobile No. 9612169565 had been deposited into the government account through Treasury Challan No. 89 dated 26.05.2014. A copy of the above mentioned Treasury Challan was also received by the Commission.
