**Subject: Order for closing of appeal case.**

WHEREAS under Section 19 of the Right to Information Act, 2005, and in accordance to the Nagaland State Information Commission (Appeal Procedure) Rules, 2005, the Nagaland Information Commission had, on 20.03.2014 and 12.06.2014 heard the Second Appeal dated 31.01.2014 received from two (2) applicants, Shri. N. Yona Konyak, Member, Vigilance Cell, NPCC, Congress Bhavan, Kohima, Mobile No. 9436001872 and Shri. K. Wetsah, Member, Vigilance Cell, NPCC, Congress Bhavan, Kohima, Mobile No. 9436001640, against the non-response from the Director & FAA, School Education, Nagaland, Kohima to their first appeal dated 18.12.2013 which was submitted against the non-response of the PIO, School Education, Nagaland, Kohima to their RTI application dated 17.10.2013.

AND WHEREAS, the Commission had, after hearing the parties on 20.03.2014, passed decision vide even No. dated 20.03.2014.

AND WHEREAS, in compliance to the Point No. I of the above mentioned decision of the Commission dated 20.03.2014, Shri. Y. Vihoshe Sema, Joint Director & PIO, School Education (now retired) had, vide letter No. ED/RTI-1/2013-14/16 dated 29.04.2014 informed that the penalty fine of Rs. 25,000/- (Rupees twenty five thousand only) had been paid through Treasury Challan No. 37 dated 29.04.2014.

AND WHEREAS, also in compliance to the Point No. III of the above mentioned decision of the Commission dated 20.03.2014, Shri. Y. Vihoshe Sema, Joint Director & PIO, School Education (now retired) had, vide letter No. ED/RTI-1/2013-14/06 dated 16.04.2014 submitted that while some information were furnished to the applicants(now appellants), the required information pertaining to the periods, 2008-09 and 2009-10 of the query Nos. 2 & 3 could not be provided due to non-availability of documentary records.

AND WHEREAS, since the Commission observed that there was no compliance to the Point No. II of the above mentioned decision of the Commission dated 20.03.2014, regarding conduct of internal enquiry and fixing of accountability for not putting up the first appeal dated 18.12.13 to either to the Joint Director & PIO, School Education or to the Principal Director & FAA, School Education, the Commission had fixed for second hearing of the parties on 12.06.2014 at 2:00 PM.

AND WHEREAS, the Commission had, after the second hearing of both the parties on 12.06.2014, passed decision vide even No. dated 20.06.2014.

AND WHEREAS, in compliance to Point No. I of the Decision of the Commission dated 20.06.2014, Shri. Zaveyi Nyekha, Director & FAA, School Education, Nagaland, Kohima had, vide letter No. ED/RTI-1/2013-14 dated July, 2014 submitted the report wherein he admitted that the first appeal dated 18.12.2013 filed by the applicants (now appellants) – Shri. N. Yona Konyak, Member, Vigilance Cell, NPCC, Congress Bhavan, Kohima, Mobile No. 9436001872 and Shri. K. Wetsah, Member, Vigilance Cell, NPCC, Congress Bhavan, Kohima, Mobile No. 9436001640, was

received by him on the same day i.e 18.12.2013, however, due to oversight and heavy official engagements, the above first appeal could not be endorsed to the Joint Director & PIO, Directorate of School Education, Nagaland, Kohima for necessary perusal of the matter.

AND WHEREAS, Shri. Zaveyi Nyekha, Director & FAA, School Education, Nagaland, Kohima had also tendered an apology to the Commission and owned the responsibility for not putting up and processing the first appeal dated 18.12.2013.

AND WHEREAS, the Commission had accepted and is satisfied with the above report and submission of Shri. Zaveyi Nyekha, Director & FAA, School Education, Nagaland, Kohima.

AND WHEREAS, in compliance to **Point No. II** of the Decision of the Commission dated 20.06.2014, the Commission had also received a copy of the nomination for training of six (6) officers of the School Education Department on RTI at the ATI, Kohima including their attendance sheet in the training.

AND WHEREAS, since compliance to **Point Nos. I & II** of the Decision of the Commission dated 20.06.2014 have been received, the Commission decided to declare the **appeal case closed.**

NOW THEREFORE, it is notified to the following parties that the appeal case is hereby declared closed:-
