**Subject: Order for closing of appeal case.**

WHEREAS under Section 19 of the Right to Information Act, 2005, the Nagaland Information Commission had on 23.01.2014 received an appeal dated **28.12.2013** (in Hindi) from an applicant, Gaurav Kumar, S/o Sh. Roshan Lal, V & PO – Biana, District – Karnal, Pin 132054, Haryana, Mobile No. 09466340982, stating that he had received incomplete information from the District Transport Officer, Zunheboto in response to his RTI application dated **02.10.2013**.

AND WHEREAS the Commission had translated the letter dated **28.12.2013** (in Hindi) into English.

AND WHEREAS the applicant had earlier submitted a RTI application dated **02.10.2013** (in Hindi) alongwith IPO Nos. 01G 210445 for Rs. 20.00, 01G 210452 for Rs. 20.00 and 09F 336807 for Rs. 10.00 addressed to the District Transport Officer, Zunheboto, seeking information on 9 (nine) queries.

AND WHEREAS the District Transport Officer, Zunheboto had, vide letter No. DTO/Z/RTI-1/2013-14/51 dated **17.10.2013** furnished some information to the applicant. However, on being not satisfied with the information so provided on the ground that it was **incomplete information**, the applicant had written (in English) to the District Transport Officer, Zunheboto on **05.11.2013** to provide the complete information.

AND WHEREAS on not getting any further reply or information from the District Transport Officer, Zunheboto, the above applicant had complained to this Commission.

AND WHEREAS the Commission had, vide letter dated 11.02.2014 and under Section 19(1) of the RTI Act, 2005, advised the applicant to file first appeal to the Transport Commissioner & First Appellate Authority, Transport and Motor Vehicle Department, Nagaland, Kohima, for providing incomplete information by the District Transport Officer, Zunheboto in response to his RTI application dated **02.10.2013**. And further, if there was no response/decision or unsatisfactory decision of the above First Appellate Authority within 30-45 days of receipt of his first appeal, under Section 19(3) of the RTI Act, 2005, a second appeal may be preferred to this Commission within 90 (ninety) days from the date on which the decision on the first appeal should have been made or was actually received.

AND WHEREAS the Commission had also observed that since in his above letter dated **28.12.2013** to this Commission, the date of his RTI application was mentioned as **03.10.2013** instead of 02.10.2013 as evidenced on the photocopy of his RTI application, and also his letter to the District Transport Officer, Zunheboto as **13.11.2013** instead of

05.11.2013 as evidenced on the photocopy of his letter, the applicant was directed to clarify the dates.

AND WHEREAS there was no response or further complain from the applicant till date even after sufficient time had elapsed, suggesting that the applicant was not serious and has no interest to pursue the case further, the Commission decided to declare the case **closed**.

NOW THEREFORE, it is notified to the following parties that the appeal case is hereby declared **closed**:-
