**Subject: Order for Closing of Appeal Case.**

WHEREAS under Section 19 of the Right to Information Act, 2005, and in accordance to the Nagaland State Information Commission (Appeal Procedure) Rules, 2005, the Nagaland Information Commission had, on 23.03.2015 (Monday) at 12:00 PM heard the Second Appeal dated 14.01.2015 received from Shri. Katovi Chishi, C/o N. Y. K. Villa, House No. 348, Below Fernwood School, Upper Agri. Colony, Kohima, Mobile No. 9856277686/ 8794754880, stating that he did not receive any information from the First Appellate Authority, Rural Development Department, Nagaland, Kohima with respect to his First Appeal dated 01.10.2014 which was submitted against the non furnishing of information by the PIO, Rural Development Department, Nagaland, Kohima to his RTI application dated 05.08.2014 even after the expiry of the stipulated time.

AND WHEREAS, the Commission had, after hearing the parties on 23.03.2015 (Monday) at 12:00 PM, passed decision vide even No. dated 25.03.2015.

AND WHEREAS, in compliance to the **point No. 1** of the above decision of the Commission dated 25.03.2015, Shri. Kelei Zeliang, IAS, Secretary & First Appellate Authority, Rural Development Department, Nagaland, Kohima had, vide summon letter No. RD/RTI-34/2011 dated 02.04.2015 notified Shri. Niehusa Nakhro, Deputy Secretary & PIO, Rural Development Department, Nagaland, Kohima and the applicant(now appellant), Shri. Katovi Chishi for a hearing again on **13.04.2015 at 12:00 noon** in his office chamber.

AND WHEREAS, after the hearing on **13.04.2015 at 12:00 noon** with Shri. Niehusa Nakhro, Deputy Secretary & PIO, Rural Development Department, Nagaland, Kohima, Shri. Benri Patton, JSO & APIO, Rural Development Department, Nagaland, Kohima and the applicant(now appellant), Shri. Katovi Chishi, Shri. Kelei Zeliang, IAS, Secretary & First Appellate Authority, Rural Development Department, Nagaland, Kohima had, vide No. RD/RTI-34/2011 dated 13.04.2015 passed a quasi-judicial order **disposing the case** as the matter was thoroughly deliberated wherein the PIO had laid all the requisite details before the court and that the applicant(now appellant) had, on examination of the records submitted full satisfaction with the response of the PIO. Copies of the Order and the information so furnished to the applicant (now appellant) were submitted to the Commission.

AND WHEREAS, in compliance to the **point No. 2** of the above decision of the Commission dated 25.03.2015, the applicant (now appellant) had, vide letter dated **13.04.2015** submitted to the FAA and with a copy to this Commission stating that having deliberated the matter to his full satisfaction during the first appeal hearing on 13.04.2015, the case may be treated as closed/disposed off. A copy of the letter was also received by this Commission.

AND WHEREAS, since the Commission had received the quasi-judicial order, disposing off the case by the FAA and that the applicant (now appellant) had also submitted full satisfaction, the Commission decided to declare the case as **closed**.
