Subject: Order for Closing of Appeal Case.

WHEREAS under Section 19 of the Right to Information Act, 2005, and in accordance to the Nagaland State Information Commission (Appeal Procedure) Rules, 2005, the Nagaland Information Commission had, on 23.03.2015 (Monday) at 1:30 PM heard the Second Appeal dated 27.02.2015 received from Shri. Rajen Puzari, Khoundpara, Dergaon – 8, P.O. Dergaon – 785614, Dist.
