**Subject: Notice for hearing on 11<sup>th</sup> June, 2014 (Wednesday) at 12:00 Noon.**

WHEREAS under Section 19 of the Right to Information Act, 2005, the Nagaland Information Commission have received a Second Appeal dated 24.03.2014 from an applicant, Shri. Vikheto Zhimomi, P.R. Hill, Kohima, Mobile No. 9089896123, 9615115300, stating that there was unsatisfactory response received from the Additional Secretary & PIO, Department of Food & Civil Supplies, Nagaland, Kohima to his first appeal dated 19.11.2013 which was submitted against the unsatisfactory response of the Joint Secretary & PIO, Department of Food & Civil Supplies, Nagaland, Kohima to his RTI application dated 16.09.2013.

AND WHEREAS, earlier the applicant had submitted a RTI application dated 16.09.2013 addressed to the PIO, Department of Food & Civil Supplies, Nagaland, Kohima alongwith an application fee of Rs. 10/-, seeking certain information on **24(twenty four)** queries.

AND WHEREAS, the above a RTI application dated 16.09.2013 was received by the public authority on the same day i.e. 16.09.2013 as evidenced on the photocopy of the RTI application.

AND WHEREAS, in response to the RTI application dated 16.09.2013, Shri. H. Lungalang, Joint Secretary & PIO, Department of Food & Civil Supplies, Nagaland, Kohima had, vide letter No. SPLY-1/20/2012(Pt-II) dated 15.10.2013 informed the applicant that the information was ready and had requested to collect it during office hours, on payment of Rs. 161.00 (Rupees one hundred and sixty one only)

AND WHEREAS, on being not satisfied with the information received from Shri. H. Lungalang, Joint Secretary & PIO, Department of Food & Civil Supplies, Nagaland, Kohima, the applicant had submitted first appeal dated 19.11.2013 addressed to the Appellate Authority, Department of Food & Civil Supplies, Nagaland, Kohima requesting to re-furnish the information relating to query **Nos. 1, 2, 8, 13, 19 and 22.**

AND WHEREAS, the first appeal dated 19.11.2013 was received by the public authority on 21.11.2013 as evidenced on the photocopy of the first appeal.

AND WHEREAS, in response to the first appeal dated 19.11.2013, Shri. H. Lungalang, Joint Secretary & PIO, Department of Food & Civil Supplies, Nagaland, Kohima, had, vide letter No. SPLY-1/20/2012(Pt-II) dated 16.12.2013 informed the applicant that since the information requested was being sought from the Directorate of Food & Civil Supplies, Nagaland, Dimapur and also in view of the Christmas Holidays, the Department would be able to furnish the information on or before 21.01.2014.

AND WHEREAS, again in response to the first appeal dated 19.11.2013, Shri. H. Lungalang, Additional Secretary & PIO, Department of Food & Civil Supplies, Nagaland, Kohima had, vide letter No. SPLY-1/20/2012(Pt-II) dated 28.01.2014 informed the applicant that except **queries No. 8 and 22**, no information over and above the information already furnished by the Department vide letter No. SPLY-1/20/2012(Pt-II) dated 15.10.2013 could be provided. And the replies to the **queries No. 8 and 22** were accordingly furnished.

AND WHEREAS, on being not satisfied with the information relating to query Nos. **2, 8, 13 and 19**, received from Shri. H. Lungalang, Additional Secretary & PIO, Department of Food & Civil Supplies, Nagaland, Kohima, the applicant had submitted second appeal dated 24.03.2014 before this Commission.

AND WHEREAS, the Commission has decided to hear the appeal, giving opportunity to the parties, on **11<sup>th</sup> June, 2014 (Wednesday) at 12:00 Noon** in the **Hearing Room of the Nagaland Information Commission, Old Secretariat Complex, Kohima**.
