WHEREAS under Section 19 of the Right to Information Act, 2005, the Nagaland Information Commission had, on **11th June, 2014 (Wednesday) at 2:00 P.M.** heard the Second Appeal dated 25.04.2014 submitted by an applicant, Shri. C. Zungkum, Chairman, Yakur Village Council, Tuensang District, Nagaland, Mobile No. 8413000543, against the non-response from the First Appellate Authority, Office of the Deputy Commissioner, Tuensang District, Nagaland to his First Appeal dated 17.02.2014, which was submitted against the non response of the ADC & PIO, Office of the Deputy Commissioner, Tuensang District, Nagaland to his RTI application dated Nil.

AND WHEREAS, during the hearing on 11.06.2014, only the applicant alongwith his representative appeared before the Commission. And on telephonic confirmation with the DC & FAA, Tuensang, it was learnt that the DC & FAA, Tuensang did not receive the Notice for Hearing, for which they could not appear for the hearing.

AND WHEREAS, the appellant was heard. However, due to the absence of the respondents i.e. DC & FAA, Tuensang and the ADC & PIO, Tuensang (for the reasons mentioned above), the Commission could not proceed the case further and hence reserved its judgement for the next hearing scheduled on 30.07.2014 at 2:00 PM.

AND WHEREAS, the Commission has decided to hear the appeal, giving opportunity to all the parties, on **30th July, 2014 (Wednesday) at 2:00 P.M** in the **Hearing Room of the Nagaland Information Commission, Old Secretariat Complex, Kohima.**
