AND WHEREAS, on receipt of the redirected Second Appeal dated 27.11.2013 (in Hindi) from the Central Information Commission, New Delhi on 24.02.2014, this Commission had translated it into English and the translated Second Appeal was received by this Commission only on <u>15.05.2014</u>.

AND WHEREAS, earlier the applicant had submitted a RTI application dated 27.03.2012 alongwith prescribed fee of Rs. 10/- paid vide IPO No. 98 E 373610 addressed to the Jan Suchna Adhikari / RTI Officer, District Transport Office, Mokokchung, Nagaland, requesting for information in respect of vehicle No. NL-02-D-2711 on the following queries:

- i. Is vehicle No. NL-02-D-8711 registered in your office? If yes, please give to me about vehicle registration date, owner's name with full address, fitness, tax with amount, insurance, vehicle model, chassis No., engine No. and quality of wheeler six or ten and body open or tanker with particular in brief. Please send available all photo copies proof.
- ii. If No Objection Certificate (NOC) is issued by your office please give issue of date and serial number with photo state copies proof.
- iii. In case above said vehicle is already registered before in other place (Transport office) then give Ex-Registration No. of vehicle and date and other particulars. Send with photo copy and other proof.

AND WHEREAS, in response to the RTI application dated 27.03.2012, the Regional Transport Officer, Mokokchung, Nagaland had, vide letter No. RTO-MKG/RTI/G-30/08/4146 dated 23.04.2012 furnished the information to the applicant.

AND WHEREAS, the applicant had filed a First Appeal dated 18.02.2013, addressed to the Appellate Adhikari/RTO, Regional Transport Office, Mokokchung, Nagaland, on ground that the information so received was **incomplete** since he had received reply to only one(1) query out of the three (3) queries.

AND WHEREAS, on receipt of the First Appeal dated 18.02.2013, the Regional Transport Officer, Mokokchung, Nagaland had, vide letter No. RTO-03/MV/MKG/09/4392 dated 06.03.2013 furnished the information to the applicant(now appellant).

AND WHEREAS, on 30.09.2013, the applicant submitted a **<u>Reminder</u>** in respect of his First Appeal dated 18.02.2013 addressed to the Appellate Adhikari/Regional Transport Officer, Regional Transport Office, Mokokchung, Nagaland, against letter No. RTO-MKG/RTI/G-30/08/4146 dated 23.04.2012 and letter No. RTO-03/MV/MKG/09/4392 dated 06.03.2013.

AND WHEREAS, since there was no response from the FAA or PIO in regard to the Reminder letter dated 30.09.2013, the applicant (now appellant) preferred a Second Appeal (in Hindi) dated 27.11.2013 before the Central Information Commission, New Delhi. However, since the subject of appeal falls under the jurisdiction of the Nagaland Information Commission the Second Appeal dated 27.11.2013 alongwith the enclosures were forwarded to this Commission.

AND WHEREAS, the Commission has decided to hear the appeal, giving opportunity to the parties, on <u>31st July, 2014 (Thursday) at 11:00 AM.</u> in the Hearing Room of the Nagaland Information Commission, Old Secretariat Complex, Kohima.
