WHEREAS, under Section 19 of the Right to Information Act, 2005, and in accordance to the Nagaland State Information Commission (Appeal procedure) Rules, 2005, the Nagaland Information Commission had heard the second appeal dated 30.10.2015 for the fourth time which was submitted by Shri. Longri Ao, Camp: Kohima, Mobile No. 943600416 against the non-response of the PIO, Finance Department, Nagaland, Kohima to his RTI application dated 10.07.2015 and also from the First Appellate Authority, Finance Department, Nagaland, Kohima to his subsequent first appeal 31.08.2015.

AND WHEREAS, after hearing the appeal for the fourth time on 07.09.2017 at 11:00 A.M, the Commission had passed its decision vide even No. dated 12.09.2017. However, on not getting any compliance to the above decision dated 12.09.2017, the Commission had, vide letter of even No. dated 15.12.2017 directed the Deemed PIO, Shri. Y. Kikheto Sema, IAS, Secretary, Finance Department & Land Resources, Nagaland, Kohima to submit compliance to the Commission on or before 20.01.2018.

AND WHEREAS, in compliance to the decision of the Commission of even No. dated 12.09.2017 and the subsequent directive of even No. dated 15.12.2017, the Deemed PIO, Shri. Y. Kikheto Sema, IAS, Secretary, Finance Department & Land Resources Department, Nagaland, Kohima submitted that the penalty amount of Rs. 25,000/- (Rupees twenty five thousand only) had already been deposited into Government Accounts vide Treasury Challan No. 11 dated 26.10.2017 and a copy of the Treasury Challan was submitted to the Commission.

AND WHEREAS, since the above compliance i.e. Treasury Challan has been received, the Commission has decided to close this appeal case.

NOW THEREFORE, it is notified to all the parties that the appeal case is hereby declared as **closed**.
