## Subject: Closing Order of Appeal case.

WHEREAS under Section 19 of the Right to Information Act, 2005, and in accordance to the Nagaland State Information Commission (Appeal Procedure) Rules, 2005, the Nagaland Information Commission had, on 22.01.2016 at 12:00 PM. heard the Second Appeal dated 03.12.2015 submitted by Shri. Vikheto Zhimomi, P.R Hill, Kohima, Mobile No. 9615115300, 9089896123, against the non-satisfaction of the information furnished by the Executive Engineer after the stipulated time frame in response to his RTI application dated 10.08.2015 and by the Director & FAA, Urban Development, Nagaland, Kohima in response to his first appeal dated 21.09.2015.

AND WHEREAS, the Commission had, after the hearing held on 22.01.2016 at 12:00 PM passed decision vide even No. dated 28.01.2016.

AND WHEREAS, in compliance to the decision of the Commission dated 28.01.2016, the Director & First Appellate Authority, Directorate of Urban Development, Nagaland, Kohima had, vide letter No. UD-NUIS-RTI/2015/case-2/357 dated 11.02.2016 submitted to the Commission that a **Joint Sitting** was held on **09.02.2016** wherein the following were discussed:-

- 1. The mis-matched sanction amount was clarified by the PIO as per query No. 1 and the applicant (now appellant) had expressed satisfaction with the clarification. However, the applicant (now appellant) stated that he would verify the documents furnished by the Department.
- 2. The missing work orders and completion certificates were furnished to the applicant (now appellant).
- 3. The amount kept in CD (Civil Deposit) was clarified to the satisfaction of the applicant (now appellant).
- 4. The excess amount of Rs. 33 lakhs under NDS (Neighbourhood Development Scheme) was clarified to the applicant (now appellant).
- 5. The cost of information for an amount of Rs. 980/- (Rupees nine hundred and eighty only) was refunded to the applicant (now appellant).

AND WHEREAS, the applicant (now appellant) had, vide letter dated 01.03.2016 submitted to the Commission that since the public authority i.e. the Directorate of Urban Development, Nagaland, Kohima had during the joint sitting furnished him the required information, had also verbally explained to him wherever clarification was needed, and had further refunded the cost of information for the amount of Rs. 980/- (Rupees nine hundred and eighty only) to him, he had requested the Commission to close the case as he was satisfied.

AND WHEREAS, since the compliance has been received from the public authority and that the applicant (now appellant) had also expressed satisfaction with the clarifications and the information so furnished to him, the Commission had decided to close the appeal case.
