## **Subject:** Closing Order of Appeal Case.

WHEREAS, under Section 19 of the Right to Information Act, 2005, and in accordance to the Nagaland State Information Commission (Appeal procedure) Rules, 2005, the Nagaland Information Commission had heard the second appeal dated 11.01.2016 submitted by Shri. Alok, S/o Shri. Mehar Singh, H.No.1508, Urban Estate, Jind-126102, Haryana on two occasions i.e. 27.10.2016 at 11:00 A.M and 22.09.2017 at 11:00 A.M.

AND WHEREAS, after the second hearing held on 22.09.2017 at 11:00 A.M, the Commission had passed its decision vide of even No. dated 28.09.2017.

AND WHEREAS, in compliance to the <u>Point No. 1</u> of the above decision of the Commission dated 28.09.2017, the Director-cum-Registrar & First Appellate Authority, The Global Open University Nagaland, Dimapur had, vide letter No. GOUN/2-14/16/B/490 dated 06.11.2017 written a final reminder to the applicant (now appellant) to confirm satisfaction or non-satisfaction of the information furnished to him on or before 20.12.2016.
