Subject: Closing Order of Appeal Case.

WHEREAS under Section 19 of the Right to Information Act, 2005, and in accordance to the Nagaland State Information Commission (Appeal procedure) Rules, 2005, the Nagaland Information Commission had heard the second appeal dated 12.01.2016 submitted by Shri. T.P. Loganathan, S/o Shri. T.V. Panneerselvam, Advocate, Podaturpet-631208, Tiruvallur District, Tamil Nadu against the non-response of the PIO, The Global Open University Nagaland, Dimapur to his RTI application dated 12.11.2015 and his subsequent first appeal dated 12.12.2015 submitted to the Director-cum-Registrar & First Appellate Authority, The Global Open University Nagaland, Dimapur.

AND WHEREAS, the Commission had heard the above second appeal dated 12.01.2016 on two occasions on 27.10.2016 at 12:00 P.M and 22.09.2017 at 11:30 A.M, and after the second hearing held on 22.09.2017 at 11:30 A.M, the Commission had passed its decision vide of even No. dated 28.09.2017.

AND WHEREAS, in compliance to the decision of the Commission of even No. dated 28.09.2017, Shri. Keluozie Kesiezie, Assistant Administrative Officer & PIO, The Global Open University Nagaland, Dimapur had, vide letter No. GOUN/2-14/16/B VOL I/507 dated 17.11.2017 submitted to this Commission copies of the three (3) Treasury Challans bearing Nos. 9, 10 and 11 all dated 16.11.2017 regarding the payment of the penalty for a total amount of Rs. 22,500.00 (Rupees twenty two thousand and five hundred only) deposited by the following three (3) '**Deemed PIOs**' which was imposed for contributing to the delay in furnishing the information to the applicant (now appellant):-
