Subject: Closing Order of Appeal Case.

WHEREAS under Section 19 of the Right to Information Act, 2005, and in accordance to the Nagaland State Information Commission (Appeal procedure) Rules, 2005, the Nagaland Information Commission had heard the second appeal dated 11.03.2016 submitted by Shri. Naresh Kumar, S/o Shri. Birbal Singh, Tuner Instructor, Govt. ITI, Narwana, Distict-Jind, Haryana – 126116, Mobile No. 09996137744 against the non-response of the PIO, The Global Open University Nagaland, Dimapur to his RTI application dated 24.02.2015 and his reminder i.e. presumably first appeal dated 07.10.2015 submitted to the Director-cum-Registrar & First Appellate Authority, The Global Open University Nagaland, Dimapur.

AND WHEREAS, the Commission had heard the above second appeal dated 11.03.2016 on two occasions on 27.10.2016 at 1:00 P.M and 22.09.2017 at 1:00 P.M, and after the second hearing held on 22.09.2017 at 1:00 P.M, the Commission had passed its decision vide of even No. dated 03.10.2017.

AND WHEREAS, in compliance to the **Point No. 1** of the above decision of the Commission dated 03.10.2017, the Director-cum-Registrar & First Appellate Authority, The Global Open University Nagaland, Dimapur had, vide letter No. GOUN/2-14/16/B/448 dated 10.10.2017 written a final reminder to the applicant (now appellant) to confirm satisfaction or non-satisfaction of the information furnished to him on or before 10.11.2017.

AND WHEREAS, the applicant (now appellant) had, vide e-mail dated 07.11.2017 informed the Commission that he was **satisfied** with the decision of the Commission and had also attached a letter dated 07.11.2017 regarding his satisfaction.

AND WHEREAS, in compliance to the **Point No. 2** of the above decision of the Commission dated 03.10.2017, Shri. Keluozie Kesiezie, Assistant Administrative Officer & PIO, The Global Open University Nagaland, Dimapur had, vide letter No. GOUN/2-14/16/B VOL I/507 dated 17.11.2017 submitted to this Commission copies of the three (3) Treasury Challans bearing Nos. 9, 10 and 11 all dated 16.11.2017 regarding the payment of the penalty for a total amount of Rs. 25,000.00 (Rupees twenty five thousand only) deposited by the following three (3) **'Deemed PIOs'** which was imposed for contributing to the delay in furnishing the information to the applicant (now appellant):-
