**Subject: Notice for Hearing on 28<sup>th</sup> April, 2015 (Tuesday) at 1:30 PM.**

WHEREAS under Section 19 of the Right to Information Act, 2005, the Nagaland Information Commission had on 13.03.2015 received a second appeal dated 13.03.2015 from Shri. S. Lepzung Jamir, Managing Director(NESMA) & Social Activist, Tuli, Mokokchung, Mobile No. 8729993847, email: nesmstuli@gmail.com, stating that he did not receive any information from the Engineer-in-Chief & First Appellate Authority, NPWD, Nagaland, Kohima to his First Appeal dated 12.12.2014 which was submitted against the non-reply by the PIO, Office of the Engineer-in-Chief, NPWD, Nagaland, Kohima to his RTI application dated 07.10.2014.

AND WHEREAS, earlier the applicant had submitted a RTI application dated 07.10.2014 addressed to the PIO, Office of the Engineer-in-Chief, NPWD, Nagaland, Kohima alongwith the prescribed application fee of Rs. 10/- (Rupees ten only), seeking the following information:-

- i. *Number of vacant post lying in the entire section of NPWD i.e. R&B, National Highway, Housing and Mechanical in the State of Nagaland from Grade I to Grade-IV.*
- ii. *Post to be vacant through retirement of service during 2014-15 in the entire section of NPWD i.e. R&B, National Highway, Housing and Mechanical in the State of Nagaland from Grade I to Grade-IV.*
- iii. *Fund sanction by the Central and State Government for various infrastructural and developmental works from 2013 to till date, by issuing withdrawal certificate received from Civil Deposit. And please give me in details about the fund released to the concerned district/ payment and receipt made to the contractor or local person and Utilisation Certificate for the fund released in district wise of Nagaland.*
- iv. *Total amount of unspent balance under various sections after utilisation from 2013 to till date.*

Further, for **Sl. No. 1 and 2** above, the applicant desired that the information be furnished in the given format below:

Furthermore, the applicant desired that the information may be sent to C/o Nayangro, Assistant Superintendent, Vigilance Commission, Nagaland, Kohima.

AND WHEREAS, the RTI application dated 07.10.2014 was received by the public authority on the same day i.e. 07.10.2014 as evidenced on the body of the RTI application.

AND WHEREAS, on not getting any information to his RTI application dated 07.10.2014 within the stipulated time frame of 30 days, the applicant had preferred **first appeal dated 12.12.2014** addressed to the First Appellate Authority & Engineer-in-Chief, NPWD, Nagaland, Kohima.

AND WHEREAS, the first appeal dated 12.12.2014 was received by the public authority on the same day i.e. 12.12.2014 and a copy of receipt of the first appeal was enclosed.

AND WHEREAS, on not getting any information till date, the applicant (now appellent) had preferred a second appeal dated 13.03.2015 before this Commission.

AND WHEREAS, since there was no information furnished or received till date even after filing of the first appeal, and there is no record of hearing of the first appeal, the Commission has decided to hear the appeal, giving opportunity to the parties, **28<sup>th</sup> April, 2015 (Tuesday) at 1:30 PM** in the **Hearing Room of the Nagaland Information Commission, Old Secretariat Complex, Kohima.**
